Narora atomic power plant

1143. SHRI B. SATYANARAYAN REDDY: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the atomic power plant at Narora is likely to be delayed further by five years;
- (b) if go, what are the reasons therefor:
- (c) what is the estimated cost escalation in the construction of the plant as a result thereof; and
- (d) what steps have been taken by remove the bottle-Government to necks in the construction of the plant?

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY, ELECTRONICS AND ENVIRONMENT (SHRI CHAN-DRA PRATAP NARAIN SINGH): (a) The two units of Narora Atomic Power Project are expected to be completed by 1986 and 1987 as against the original scheduled dates of 1981 and 1982 respectively.

- (b) and (d) The project is behind schedule on account of problems faced in land acquisition in the initial stages, additional time required to finalise designs after conducting seismic analysis and delayed delivery of major nuclear components due to factors beyond the control of the Department. Necessary steps are being taken to expedite the manufacture of various components which govern the project schedule. Erection and commissioning activities are being parallelled to the extent feasible.
 - (c) The component of cost escalation directly attributable to the delay in completion of the project is not **g**ubstantial
