Manufacturing of electronic watches in India

1125. SHRI KALPNATH RAI: Will the PRIME MINISTER be pleased to Mate:

(a) whether any plants have been set up in India by Government to manufacture electronic watches; and

(b) if so, what are the details thereof and whether they have started production?

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY, ELECTRONICS AND ENVIRONMENT (SHRI CHANDRA PRATAP NARAIN SINGH): „(a) and (b) The central public sector company M/s. Semiconductor Complex Limited (SCL) has been approved by Government to manufacture, at its

plant at Chandigarh, the electronic module of digital electronic watches in technical collaboration with M/s. Hitachi of Japan. Letters of Intent have been issued in December, 1980— January, 1981 to 13 units in the large scale sector, and industrial approvals to 25 units in the Small Scale Sector, for the assembly of digital electronic watches using the modules made by M/s. SCL. It is expected that some of these units would start production in early 1982. As for the electronic modules which go into quartz analogue watches to be made by M/s. HMT with the technical assistance of M/s. Citizen Watch Company of Japan, and by M/s. Hyderabad Allwyn in technical collaboration with M/s. Seiko of Japan, M/s. SCL has concluded arrangements with both the Japanese companies concerned for it to make the electronic modules which go into such electronic watches also. Both HMT and Hyderabad Allwyn have already introduced their Quartz analogue electronic watches in the market and M/s. SCL expects to be able to produce electronic modules going in these watches from next year.
