

from the organisers of the Seminar. As such the Government have no authentic information regarding the statement attributed to the Regional Director of W.H.O. in India. However, Press Reports have appeared stating that Dr. B. B. Gatonde of W.H.O. had said that 30,000 formulations in India have not been evaluated for their safety.

(b) Under the Drugs and Cosmetics Act control over the manufacture and sale of drugs is exercised by the State Drug Control Authorities. The State Drug Controllers are the licensing Authority for manufacture of drugs and manufacturing licenses for manufacture of drug formulations are issued by them. State Drug Controllers while issuing manufacturing licences for formulations are required to screen drug formulations particularly combinations to ensure that that they contain, the constituents ingredients. Therapeutic/prophylactic quantities, are safe for use and contain such ingredients and in such quantities for which there is therapeutic justification. The State Drug Controllers licence drug formulations in the context of information available regarding the toxicity of these drugs or their incompatibility, it would therefore not be correct to say that drug formulations have not been evaluated for safety from the health point of view. It is possible that after drug formulations have been licenced for manufacture and have been marketed for many years, reports may come to notice regarding the toxicity of some of the drugs or their incompatibility. Medical opinion regarding the use of these drugs may also change over a period of time. Thus while in the past medical opinion was not against the marketing of drug combinations, during recent years medical opinion has now veered towards the prescribing of drugs as single ingredient preparations. Drug regulatory agencies have consequently begun re-evaluating drug combinations marketed from the angle of safety and efficacy in light of current knowledge.

(ख) क्या सरकार बढ़ते हुए मूल्यों के कारण छात्र-वृत्ति को राशि बढ़ाने का विचार कर रही है ; और

(ग) इसी प्रकार क्या सरकार पात्र छात्रों के अभिभावकों की अधिकतम आयु सीमा भी बढ़ाने पर विचार कर रही है ?
