(b) to (e) 19 regular appointees to Group 'A' junior scale have already been placed in the senior scale posts on ad hoc basis on different dates since November 1978. They are in receipt of senior scale pay from the respective dates of placement in the senior scale on ad hoc basis. 22 ad hoc appointees in the junior scale who are also holding senior scale posts, will be considered for placement in the senior scale in their turn.
