Clearance to Vizhinjam Transshipment Terminat

- 379. SHRI A. VIJAYARAGHAVAN: Will the Minister of SHIPPING, ROAD TRANSPORT AND HIGHWAYS be pleased to state:
- (a) the present position of Vizhinjam deep water International Container Transshipment Terminal;
 - (b) whether Government have given clearance to this scheme; and
 - (c) if so, the details thereof?

THE MINISTER OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI T.R. BAALU): (a) to (c) Vizhinjam is Minor port being developed by the Government of Kerala responsibility for development of ports, other than Major Ports, vests with the State Governments concerned, which in this case is Government of Kerala. Government of Kerala has informed that competitive Bids had been invited for the project for development of Deepwater International Container Transshipment Terminal at Vizhinjam. Government of Kerala has accepted the Bid proposal on 25.1.2006. They have sent the proposal for clearances, if any, that may be required from the Government of India. As far as Government of India is concerned, clearance from security angle is required to be given, which is under process.

Launch of GSLV-F02

- (b) The exact reasons for failure are under investigation by an expert Failure Analysis Committee (FAC) set up by ISRO.
 - (c) Yes, Sir.

(d) A Failure Analysis Committee has been set up with experts from ISRO, academia and national research laboratory to ascertain the reasons for failure. The Committee is expected to submit its findings within one month.
