## **Street Lighting: in Trans-Yamuna Colonies**

1962. SHRI AMARPROSAD CHA-KRABORTY: Will the Minister of ENERGY be pleased to refer to the Unstarred Question 749 given in the Rajya Sabh<sub>a</sub> on the 30th November, 1981 and state:

- (a) whether the DESU has since taken up or propose to take up the. matter with the P.W.D. Delhi Admi-nistration/MCD regarding the receipt of the estimated cost of Rs. 6.49 lakhs needed for executing the scheme for providing street lighting on Outer Ring Road between Vivek Vihar and Suraj Nagar from NH-way to G.T. Road;
- (b) if so, what are the details thereof; and
- (c) if the answer to part (a) above be in the negative, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) and (b). Delhi Electric Supply Undertaking has taken up the matter with PWD Delhi Administration for making payment of the estimated cost of providing street lighting on the Ring Road between Vivek Vihar and Suraj Nagar in August, 1980. The PWD Delhi Administration is also being reminded periodically. DESU will take up the work on receipt of payment from the PWD Delhi Administration.
