AND RURAL RECONSTRUCTION (SHRI R. V. SWAMINATHAN): (a) and (b) The booth has been commissioned on 25th November, 1981.

Production and Supply of Edible Oils

2155. SHRI KALPNATH RAI: Will the Minister of CIVIL SUPPLIES be pleased to state:

(a) what is the estimated requirement of edible oils and its production in the current year;

(b) whether the estimated production is likely to fall short of the requirements; if so, what are the reasons therefor; and

(c) what steps Government have taken or propose to take to make good the shortfall in the production and supply of edible oils?

THE DEPUTY MINISTER IN THE MINISTRY OF CIVIL SUPPLIES (SHRI BRAJMOHAN MOHANTY): (a) and (b) The total requirement of edible oils during the current oil year (November 1981 to October 1982) is estimated to be around 39 lakh tonnes. The indigenous production of edible oils during the same period is estimated to be between 26 to 27 lakh tonnes. During the last several years, there has been a gap between the demand for edible oils and their indigenous production; and the same position is expected to continue during the current oil year also.

(c) Adequate quantities of edible oils are imported through the State Trading Corporation for allocation to the States/Union Territories for the public distribution system and to the vanaspati industry.
