Newsprint supply to Newspapers at State Capitals

Will the Minister of INFORMA-TION AND BROADCASTING be pleased to state the latest position regarding the supply of newsprint to newspapers at the State Capitals and at other newspaper centres on cash and carry basis?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (MISS KUMUD-BEN M. JOSHI): In order to make newsprint available as close to the place of publication of newspapers as possible the State Trading Corporation has already opened 8 inland depots at Ahmedabad, Sahibabad, Delhi, Jaipur, Nagpur, Gauhati, Bangalore and Hyderabad and propose to open a few more. Further to facilitate easier distribution of newsprint on the pattern of 'cash and carry' basis, the newsprint allocation policy of the Government already provides for the State Government Corporations undertaking such work on behalf of the newspapers.
