(b) Rubber Board is implementing various schemes for development of natural rubber in the country. The most important scheme is the Rubber Plantation Development Scheme which aims at accelerating new planting and replanting of rubber in an area of 60,000 hectares during the Sixth Plan period by providing incentives to the rubber growers by way of Cash Subsidy ranging from Rs. 3000 to Rs. 5000 per hectare, interest Subsidy on loans advanced by ARDC, free advisory and extension support etc. The Board has been granting additional assistance to small growers owning upto 6 hectares of land under rubber by reimbursing the total cost of planting materials, 50 per cent cost of prescribed fertilisers applied during the maturity perod of planting and subsidising soil conservation work at the rate of Rs. 150/- per hectare. The Board maintains 10 rubber nurseries for distributing high yielding planting

material at concessional rates for accelerating the development of natural rubber.
