- (c) The information is so voluminous that it is not feasible to place the whole list on the table of the House.
- ,(d) Those who claim pension on the basis of participation in RIN Mutiny are granted pension after confirmation from the list provided that there is no unsuitable remarks against their names.
- (e) No separate records are however maintained regarding the number of such pensioners.
- (f) Applications for grant of Sam-man Pension had been invited upto 31-7-1981 which date has since been extended. Such Freedom Fighters can, very well, file their Samman Pension Claims upto 31-1-1982

No date or month has, however, been fixed for its release. The work relating to the pre-peration of the CSS Selection Grade Select List for the year 1981 is in progress and the list will be issued as soon as practicable.
