Empanelment for the post of Joint Secretary

429 SHRI DHULESHWAR MEENA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that the empanelment of officers belonging to certain Group 'A' services for the level of Joint Secretary's rank have been delayed by two to three years;
- (b) what is the latest year for which I.A.S. officers have been screened for the posts of Joint Secretary; and
- (c) whether it is being done regularly and on time if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI P. VENKATASUBBAIAH): (a) No Sir. The assessment of eligible officers belonging to Central Group 'A' services for their suitability for holding posts at the level of Joint Secretary is undertaken as and when their complete service particulars are furnished by the respective Cadre Controlling Authorities.

- (b) I.A.S. officers are assessed for the posts of the level of Joint Secretary after they have completed 17 years of service. I.A.S. officers upto 1963 batch have since been assessed for holding Joint Secretary level posts at the Centre. The assessment of I.A.S. officers of 1964 batch is now being taken up.
