THE MINISTER OF STATE IN THE DEPARTMENT OF SCIENCE TECHNOLOGY, ELECTRONICS AND ENVIRONMENT (SHRI CHANDRA PRATAP NARAYAN SINGH): (a) and (b) The latest position with regard to India's nuclear efforts for peaceful purposes is that considerable progress has been made in the problems connected with Fast Breeder Test Reactors, use of atomic energy in agriculture, medicine and industry besides generation of power. The main areas of application are:-

I. Agriculture

(i) Development of new mutants of various fibre crops, cereals, pulses, ·etc.

- (ii) Sterilisation of certain posts by radiation techniques.
- (iii) Radiation preservation of food in natural form for extended periods.

II. Medicine

- (i) Special diagnostic and therapeutic techniques using radiosotopes. 5. 1
 - (ii) Radiation sterilisation of medical products.

III. Industry

- (i) Use of radioisotopes in indus-
- (ii) Inspection techniques and other radiation based procedures.

Within the resources available to the Government, every effort is made to undertake research and development in all aspects of peaceful utilisation of nuclear energy and to keep the country abreast of the latest developments.
