Finally, this year they have sent five letters to the Minister of Education and three telegrams. Minister of Education does not deem it necessary to answer those letters. I would like to ask the Minister, if teachers are driven to this condition and they are forced to have demonstrations, if this is the kind of treatment that is meted out to teachers, what will be the treatment meted out to people like to working class and poorer sections? So, the absolute apathy, indifference, even to their representation, going to the extent of not even acknowledging their letters, has led to a situation where the entire teachers of the Delhi University are now on a 'dharna', and if it is not attended to immediately, it may lead to a strike; vou are driving even the teachers to position of strike. The workers may also have to go on strike. The entire society is being forced to take direct action. Therefore, it is high time that the Education Minister sends for them, discusses with them and tries to come to some amicable settlement with regard to their grievances. After all, if you say that teachers are unreasonable, then who is going to be reasonable in this world? If teachers are unreasonable, if people are unreasonable, workers are unreasonable, RAW employees are unreasonable, if everybody is unreasonable, then are you being reasonable by not even acknowledging their letters? If this is the kind of yardstick that is going to be applied, then, I am afraid this Government will be a totally non-functioning Government and people will get absolutely 'disgusted. Therefore, I want the Minister to immediately send for them and have a dialogue, so that they are not forced to take further direct action, so that the entire student community will not suffer. If they go on strike, then the entire student community of Delhi University will also suffer. Their academic courses will suffer. Therefore, I want the Minister to do that. That is all.

REFERENCE TO THE ALLEGED ATTEMPT ON THE LIFE OF THE CHIEF MINISTER OF TAMIL NADU

SHRI R. RAMKRISHNAN Nadu): Mr. Deputy (Tamil Chairman, Sir, I would bring to the notice of the Government and this hon. House the recent attempt on the like of the honourable Chief Minister of Tamil Nadu, Shri M.G. Ramachandran. Sir, this is the third time in one year when people are trying to get at his life. First time when he was going in a train, some Opposition party workers threw stones at the train and he was bruised. Second time when he was going settle the Naxalite problem. there was a bomb thrown. And recently when he went to settle the dispute between the Rock Memorial Centre and ferry people, personally, and he was settling the matter, a man at the Maniyachi station threw one-and-a-half foot long knife. Fortunately, one of his men was opening the door of the compartment, and the dagger could not reach him. You know, Sir, that recently the Tamil Nadu Government promulgated an Ordinance when 24 village officers who were enjoying hereditary rights, were almost running riot, doing all sorts of things, indulging in all sorts of things, like raping of women etc.; money-lenders doing all sorts of things loan-sharing etc. and he wanted to put an end to this system and recruit fresh people and because of this one of these persons, who was stated to be an executive of the State Village Officers' Association attempted to take the life of the Chief Minister. Sir, there is evidence to show that sympathiser of a leading he is Opposition party in Tamil Nadu. Is it a democratic behaviour that anybody should incite violence and take the life of people? Is this the way democracy should be run, Sir?
