## Mega Power Project in Orissa

\*119, SHRI B.J. PANDA:
MS. PRAMILA BOHIDAR:

Will the Minister of POWER be pleased to state:

- (a) whether the Power Finance Corporation proposes to set-up 4,000 MW altra mega power project in Orissa at a cost of Rs. 15,000 Crores;
  - (b) if so, the details thereof; and
- (c) the time-frame within which the project would be set-up and completed?

THE MINISTER OF POWER (SHRI SUSHILKUMAR SHINDE): (a) and (b) The Ministry of Power through Power Finance Corporation has taken an initiative for facilitating the development of a few 4,000 MW Ultra Mega Power Projects (UMPP) under tariff based competitive bidding route envisaged under Section 63 of the Electricity Act, 2003 through project specific shell companies. Central Electricity Authority has identified potential pit head sites in Orissa for development of Ultra Mega Projects.

(c) It is estimated that the first unit would be completed in four to five years from the date of selected bidder being in position. Other units will be completed after a time interval of 6-8 months depending on unit size.

## UNICEF report on education in Bihar

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) The UNICEF report captioned "State of the World's children 2006" is an annual publication commenting on status of the World's children, particularly with respect to the internationally notified Millennium Development Goals. It gives data on respective countries. Government of India is addressing the educational requirements of children in the 6-14 years age group through several Centrally-sponsored programmes like the Sarva Shiksha Abhiyan and the Mid Day Meal Scheme.
