I was very sorry that this should have happened on my birthday. I, have never had a birthday like this and I do not think I will have another birthday like this. \ am not enamoured of being in the House. I am not enamoured of any job. If I, wanted it, I could do it. I, could go sycophant and all the rest of it. But I am here because you wanted me and I, am assuring you-and I am going on the recordthat I will continue only here so long as all of you have confidence in me. But there are occajsions when somebody may feel offended; somebody may feel frustrated; somebody may feel upset that his version was not before the House because I did not give him a chance. I, cannot give everybody a chance. When T try to give more chances, the charge is: you fixed eight minutes, you passed beyond it. If I am strict about eight minutes, there is a howl: if I do not stick to it, there is a howl.

From tomorrow I am giving another chance. At the seventh minute, this bell will be rung and on the eighth

minute, in the middle of a sentence, I, will stop anybody. And I shall choose only those people who are there. For the rest of the week, I shall try this experiment, after which I shall decide what next to do.

Thank you very much for the kind sentiments which have been expressed by the Leader and members of Parties. I, value them and I value them much more than anything else that you have still got confidence in me and that you still think that I can be fair and just to all concerned. Thank you very much.

We have wasted too much time. I hope we will now proceed with the business of the day in the spirit in which the nation expects you to conduct the business of this House.
