श्री शिव चःद्र झाः पेपसं ग्राए नहीं। 5 बजे स्वह तक. . . (Interruptions). . .

श्री पील मोदी (गुजरात) : दो-दो ग्रादमी साथ नहीं बोलें।

SHRI MANUBHAI **PATEL** (Gujarat): Sir, ....

**JASWANT** SHRI **SINGH** (Rajasthan): It is not the Secretariat, we cannot blame the Secretariat.

SHRI MANUBHAI PATEL: Sir, in the absence of any paper we are not able to understand.... (Interruptions) This is nothing against the Secretariat because we were sitting last night up to 12.00 and beyond. But this morning before coming to the House we were completely blank as to the business of the House because we have not received papers of today's business.

श्री सभावति : ग्रापको भी यही कहना है क्या

AN HON. MEMBER: Sir, the same was the difficulty with me also.

SHRI P. N. SUKUL (Uttar Pradesh; : There is a point of order... {Interruptions}

SHRI NAGESHWAR PRASAD SHAHI: There is no point of order. It is the rale—there can be no point of order on a point of order. I am on a point of order. You cannot raise a point of order on that. {Interruptions) My submission is that the whole business which was carried on at 12.00 and after that time is illegal and unconstitutional.

MR. CHAIRMAN: Mr. Shahi, may I say one thing? When the Deputy Chairman sits in this " hair he is 'me' and I cannot sit in judgement over his action; otherwise ever)' day I will have to be hearing appeals, revisions, reviews and what not.

SHRI NAGESHWAR PRASAD SHAHI: Correct. But the Deputy Chairman cannot be the Chairman. According to the Constitution, the Depty Chairman cannot be the Chairman.

M:R. CHAIRMAN: Mr. Shahi, when he sits in this Chair, he is 'me' and he is nobody else.

SHRI NAGESHWAR PRASAD SHAHI: Sir, you are the Vice-President of the country and you are the Chairman of the House. The Deputy Chairman is not the Vice-President and therefore he cannot be the Chairman.

MR. CHAIRMAN: The Vice-President is a quite different entity. {Interruptions}

SHRI J. K. JAIN (Madhy\* Pradesh): Sir, they have no regard for the Chair.

SHRI PILOO M(5DY: Mr. Chairman, I am very happy ...

MR. CHAIRMAN: It is always a pleanure to hear Mr. Mody.

SHRI PILOO MODY: Sir, I am very happy to hear you make this remark about the Deputy Chairman that when he is occupying your Chair he is the Chairman. And, Sir, we normally are concerned with the Chair, not so much with the individuals. But when it comes to deciding matters at rh • zero hour day after day, the Deruty Chairman and all others occupying this Chair—other than yourself—have the habit of trying to sidetrack the issue by saying that the Chairman is not here and I will have to ask him before giving a ruling. So, you cannot have it both ways. I would much rather prefer.....Mr. Secretary-General. kindly do not distract his attention from me.

MR. CHAIRMAN: I have been accustomed to looking at two things at the same time for almost 25 years.

SHRI PILOO MODY: I have got difficulty in catching your eyes, one at a time. If you can miss something like me, how do you say that you can look at two things at the same time?

CHAIRMAN You MR overshadow so many people.

SHRI PILOO MODY: Therefore, Sir, I would very willingly accept your current ruling that whoever is sitting in the Chair must. have the full powers of the Chair to decide all issues.

MR. CHAIRMAN: As we do in Supreme Court, in courts everywhere, if I sit on a division bench, I can decide it. But we say, no. I would reserve it for a bigger bench. Really speaking, when the Deputy Chairman the Vice-Chairman reserves something for me, they think that it is a matter important enough for me to know and to decide. I think that is a very legitimate operation, and I think you should not try that I

sheuld countermand it. It will be open.. .

SHRI PILOO MODY: I would like to check his abuse.

MR. CHAIRMAN: That is all right. Mr. Mody, if you begin checking abuse, there will not be half the work done in the House.

# RE. DELAY IN INDIAN AIRLINES FLIGHTS

^ PROF. RAMLAL PARIKH (Gujarat): I want to make a small submission and bring to your attention that yesterday the Indian Airlines from Bombay did nor take off, and four MPs were stranded at Ahmedabad, who wanted to come here, including Members from the other side. I wish you told the Minister in charge of Civil Aviation that the Airlines should become regular because from morning 7 o'clock we waited at the Ahmedabad Airport. The plane arrived at 12 midnight and we were deprived of participating in the voting.

MR. CHAIRMAN: Professor Saheb, do you want the Minister to be present at every flight?

PROF. RAMLAL PARIKH: He can enquire into the matter.

MR. CHAIRMAN: He will enquire into it. I do not think that it was deliberately done.

SHRI PILOO MODY (Gujarat): The matter can be solved by installing voting machines at every airport.

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA): Mr. Piloo Mody does not agree with the hon.Member.

MR. CHAIRMAN: No, no. If you instal machines everywhere, Mr. Piloo Mody will not be seen in this House.

SHRI PILOO MODY: What a relief for you, Sir!

MR. CHAIRMAN: He will look into it. I think we will stop it there. (Interruptions). I think I will tell the Deputy Chairman. He will read the proceedings. That is all.
