SHRI ERA SEZIHIYAN (Tamil Nadu): Sir, Mr. Chavan has placed on the Table of the House certain papers and in an item you will find for some documents statements giving reasons for the delay in laying the documents on the Table of the House. Here the document is for 1977-78-Annual Accounts of the Aligarh Muslim Universitywhich is being placed now, probably it is too long ago. Tw₀ days ago, I think on 17th or so, I raised a similar objection, and the honourable Minister was pleased to say 'it is coming'. I do not knew when it is coming. The Minister said in a very casual and nonchallant manner, "It is coming"...

MR. CHAIRMAN: You are complaining of delay upon delay...

SHRI ERA SEZHIYAN: The second thing is here this item, (i) Annual Accounts of the Aligarh Muslim University—this is for 1977-78 and there is no explanation for this delay. Why should they take such a long time? Then there is no explanation offered in the House..

SHRI S. B. CHAVAN; As soon as these reports are issued by the Government, we take the earliest opportunity to place them on the Table of the House.

MR CHAIRMAN: You will hurry them

SHRI ERA SEZHIYAN: Sir, that is not the point...

MR. CHAIRMAN: Mr. Sezhiyan, you may remember, T asked you to be kind enough to come into my Chamber so that we can find out the reasons for the delay .. .

SHRI ERA SEZHIYAN: I am com. ing to your Chamber but...

MR. CHAIRMAN: Not for this purpose. So let us take some time, both of us, sit down, investigate into the delay and find out what the causes are and how they can be eliminated.

SHRi ERA SEZHIYAN: Sir, rules have been proposed for forming a committee to go into the matter, but they have not been considered yet,

MR. CHAIRMAN; You have proposed so many amendments and rules that we are doing nothing except considering your amendments. This has not been reached.
