THE MINISTER OF FINANCE (SHRI R. VENKATARAMAN): (a) A statement is attached (See below). showing the information regarding number of foreign companies together with the equity levels permitted under FERA

- (b) and (c) Equity levels of foreign companies have been determined in terms of the FERA guidelines having regard of the structure and character of activities undertaken by the company concerned. Higher levels equity have been allowed to companies which are predominantely engaged in Appendix I areas. manufacturing activities involving sophisticated technology and exports. By and large the FERA companies have conformed the structure of activities. There has thus been a 'trade off' between higher equity levels and the contribution made by them to the economy in priority areas of production. It however difficult to quantify the resnlts.
- (d) Dilution of foreign equity and Indianisation under Section 29 of the FERA is a one time effort and the process is already complete. The question of further review of this process does not arise.
