(a) the acreage of land declared surplus under various Land Ceiling Acts and distributed amongst landless labourers by the Centre and by various State Governments during the period from 1st January, 1980 till 30th October, 1980; and

(b) whether any guidelines have been issued by Government for speedy implementation of land reforms, actual delivery of possession and preparing record of rights in favour of these allottees?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RECONSTRUCTION (SHRI RURAL BALESHWAR RAM); (a) No land is distributed by the Union Government. According to reports available with the Union Government, a net area of 36,025 acres was declared surplus after 1-1-1980 under the revised Ceiling Laws The State/Union Territory-wise distribution of ceiling surplus land is given in the attached statement.

(b) State legislations on land ceiling are generally in conformity with the National Guidelines formulated in 1972. The State Governments have been requested to initiate positive steps to accelerate the pace of implementation, ensure quicker distribution of surplus land to the landless and to protect the interests of the allottees. The States were also called upon to take steps to ensure that the names of the new allottees of surplus land were invariably recorded immediately in the revenue records.
