Besides, the Regional Offics_s attend i to programmes, such as Book Exhibitions, symposiums etc., in the respective regions.

1297. SHRI AJIT KUMAR SHARMA: Will the Minister of EDUCATION be pleased to state:

- (c) how many books in all the Indian languages have been given awards till 1979;
- (d) whether the above books have been translated into all the Indian languages, and if so, what are the details thereof; and
- (e) whether the Akademi has any scheme to get the best works in each Indian language translated into all the other Indian languages and publish them?

THE MINISTER OF EDUCATION AND SOCIAL WELFARE (SHRI S. B. CHAVAN): (a) The Sahitya Akademi has published 1020 publications upto 31st March 1980.

- (b) Forty five world classics were translated and published in some of the Indian languages.
- (c) Upto 1979, 333 books have been given awards.
- (d) No, Sir, the Akademi has translated and published 12 of its award-winning books into other languages.
 - (e) Yes, Sir.

Central School, R. K. Puram, Sector IJ; New Delhi

Controversy over Award of Narmada Water Dispute Tribunal

1299. PROF. RAMLAL PARIKH: Will the Minister of IRRIGATION be pleased to state:

(a) whether some of the concerned State Governments have disputed 57

some aspects of the Award of Narmada Water Dispute Tribunal;

- (b) if so_i what are thme issues involved in the dispute; and
- (c) what steps Government propose to take to ensure timely implementation of this project of national importance?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI Z. R. ANSARI): (a) and (b) In January, 1966 the Governments of Gujarat and Rajasthan entered into an agreement for the utilisation of the waters of the Mahi river by construction of Kadana Dam in Gujarat and Banaswara Dam (Bajajsagar Dam) in Rajasthan. The agreement envisaged that, at a later date when Narmada development takes place and when Mahi areas are taken over by Narmada, I of Kadana waters may be released for use in Rajasthan. The Narmada Water Disputes Tribunal, in its decision, did not allocate any waters for use in Mahi areas. The Government of Rajasthan has taken a stand that, irrespective of the decision of the Narmada Tribunal, the agreement of 1966 should be implemented and that waters from Kadana Dam may be made available for use in Rajasthan areas. This view is not acceptable to Government of Gujarat.

(c) The Government of India in the Ministry of Irrigation is shortly convening a meeting with State Governments of Gujarat and Rajasthan to sort out the matters on the use of Mahi and Narmada waters between the two States.

However, as directed by the Narmada Water Disputes Tribunal, the Government of India have constituted Narmada Control Authority and Sardar Sarovar Construction Advisory Committee in September, 1980 to help timely implementation of the project.

Processing of Sardar Sarovar Project

1300. PROF. RAMLAL PARIKH: Will the Minister of IRRIGATION be pleased to state:

- (a) whether Rajasthan Government have sent any communication to the World Bank regarding the processing of the Sardar Sarovar Project under Narmada Watei' Tribunal Award;

- (d) whether the Central Govern ment have taken any steps to clarify the position to concerned State Gov ernments, if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI Z. R. ANSARI); (a) No, Sir.

- (b) Does not arise.
- (c) and (d) There are differences between the Governments of Gujarat and Rajasthan on the revised report of Sarda_r Sarovar Project prepared by the Government of Gujarat m January, 1980. According to Rajasthan Government, this report has omitted areas in Mahi command for irrigation from Narmada waters in violation of the 1966 agreement reached between the two State Governments on the use of Mahi waters. Thi_s view is not acceptable to Government of Gujarat.

When this question was referred to the Central Government, it advised both the States that the issue should be settled bilaterally in an amicable manner. However, in order to expedite the settlement of this question, the Union Minister of Irrigation offered his good offices to discuss the matter with the Chief Ministers of Gujarat and Rajasthan. Such a meeting is expected to be held shortly.
