up so an independent laboratory in its own right to cover research in modern biology; and several branches etc. of existing laboratories.

The establishment of the laboratory in Madhya Pradesh has been under consideration of CSIR and the Planning Commission for some time; it has also been looked into by an Expert Committee constituted for the purpose whose report was considered and approved by the Governing Body of CSIR at its meeting held on 22-10-1980. The principal areas of thrust of the laboratory are to be (i) forestry; (ii) minerals and (iii) agriculture relating to the region.

(c) and (d) We have not come across any criticism in this regard.

## Deputationist<sub>s</sub> working in National Sample Survey

1441. SHRI Ng. TOMPOK SINGH: Will the Minister of PLANNING be pleased to state:

- (a) the number of deputationists working in the National Sample Survey belonging to groups (a) and (b) at present:
- (b) whether it is a fact that some deputationists were appointed at the initial stage even though they did not fulfill the conditions as stipulated in the Recruitment Rules, if so, what is their number;
- (c) how many deputationists have completed their normal deputation period and how many of them are overstaying beyond the period of deputation;
- (d) if the reply to parts (a) and (b) above be in the affirmative what are the reasons for which these deputationists are not being reverted to their parent offices; and
- (e) what action is contemplated against the authorities responsible for their overstay?

(SHRI SHIVRAJ V. PATIL): (a) The number of officers on deputation is NSSO is as under:—

Group 'A' — 5 Group 'B'—2

- (b) The appointments of Group 'A' Officers is in accordance with Recruitment Rules. The initial appointments of Group 'B' Officers were made before the recruitment rules were framed. Both the appointments have since been regularised in accordance with the provisions of the relevant recruitment rules.
- (c) One Group A' Officers and two Group 'B Officers here completed their normal deputation period but are being continued on deputation with the approval of the Competent Authority.
- (d) The officers are being continued on deputation in public interest.

- (a) whether it is a fact that the Working Group of the Planning Commission has listed high morbidity and mal-nutrition, particularly among childern of weaker sections as some of the serious problems facing the country and has suggested to start more child welfare schemes.
