malnutrition among various socioeconomic groups particularly among
those below the poverty line. They
mentioned that landless agricultural
labourers people living in slum areas,
drought prone and remote tribal areas
are vulnerable to nutritional disorders. They also pointed out that
children, pregnant women and nursing mothers are in particular affected
by malnutrition.

The Task Force suggested the initiation of integrated programme consisting of provision of employment, health services, immunisation safe drinking water, improvement of environmental hygiene and sanitation, health and nutrition education, public distribution system, housing and clothing programmes.

(c) The Planning Commission would take the Report of the Task Force into consideration while formulating the Plan.

1443. SHRI NAGESHWAR PRA-SAD SHAHI: Will the Minister of PLANNING be pleased to state the details of the Village Plan Register Scheme and by when it will be implemented?]

†[THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): Sixth Year Plan Framework envisages that the household will be the basic unit of identification for assistance development for poverty eradication in the target group of the rural poor. One suggestion under consideration is that a Village Plan Register may be maintained in each village under the Integrated Rural Development Programme, which will give complete economic status of poor families in the village, the programmes of development envisaged for them, assistance actually provided to them and the follow up of such assistance in terms of impact on development of the family income etc.]

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): (a) The Planning Commission was reconstituted in April, 1980. There is at present no proposal to reorganise it.
