- (d) The steps taken to ease infrastructural bottlenecks and to provide a positive policy thrust for stepping up industrial production would take some time to get effectuated and, the position may be expected to improve in the coming months.

(c) Government take into consideration all such factors including any unusual military build-up while periodically updating our defence plans.

However, Kerala State Industrial Development Corporation have various proposals for setting up of projects for Nylon Filament Yarn, Caustic Soda, Vinyl Acetate Monomer, Bone processing, Newsprint Paper, titanium Metal, Measuring Instruments, Precision Ceramic Fibre, Kraft Paper Asbestos Cement Sheet etc. in Joint Venture Sector during the Sixth Five Year Plan period.
