Anti-Cancer Drug

\$1411. SHRI SURENDRA MO-HANTY: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the National Chemical Laboratory, Pune, and the Maharashtra Government Institute of Science have produced an anti-cancer drug from Vinoa Rospac (Sadabahar in Hindi); and
- (b) if so, whether the drug has been tested and the claim by this Institute verified?

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY AND ELECTRONICS (SHRI C. P. N. SINGH):
(a) National Chemical Laboratory (NCL), Pune, under a scheme partly financed by the Government of Maha-

rashtra, has produced anti-cancer drug Vinblastine as its sulphate from the leaves of Vinca Rospac (Sadabahar).

(b) Vinblastine sulphate has been in clinical use in the world as an anticancer drug. In India it has so far been imported. The product obtained by the NCL process is identical with the imported drug. There is no need for animal or clinical trials as it is an established drug.

Ship Repairing Project for Haldia

†1412. SHRIMATI KANAK MUKH-ERJEE: Will the Minister of DEFENCE be pleased to state:

- (a) by when the work on the proposed ship repairing project for Haldia, West Bengal, is expected to be taken up for construction; and
- (b) whether any project report has been prepared and if so, what are its salient features

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ V. PATIL): (a) and (b) A Project Report has been prepared for a shiprepair yard at Haldia. The report envisages setting up of one big dry dock, one small dry dock, one wet basin, workshops and other ancillary facilities. As investment decision has yet been taken on the proposal, the question as to when construction work will commence, does not arise.
