

if THE MINISTER, OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YCG3NDRA, MAKWANA): (a) to (c) A statement i<sub>s</sub> laid on the Table of the House.

### Statement

According to information furnished toy the State Government of Uttar Pradesh dated the 16th November, 1980, a Faruqi Alam procession consisting Of about 2,000 persons was passing through College Bazar street in Kanpur on 14th November, 1980 when some miscreant<sub>s</sub> tried to snatch an ear ring of a small girl seated in a buffalo cart in the procession. This incident led to a scuffle and exchange of a few brickbats. Police and Magistrate immediately controlled the situation with their intervention, and the procession passed peacefully. Two cases wer<sub>e</sub>" registered, including one against the processionists for causing damage to a scooter. Patrolling throughout the~"city wa<sub>s</sub> intensified. As a sequel to thi<sub>o</sub> incident, exchange of brickbats and fire took place between two groups of people on the 15th November, 1980, resulting in injury to 12 persons including 2 police officials. Of the injured persons, one succumbed to hi<sub>s</sub> injuries. Most of the other injured persons were discharged after treatment. A total of "59 persons were arrested upto the 16th November, 1980. curfew was imposed i<sub>o</sub> the affected areas. l

### Rusting of Light, Medium and Heavy Armaments

•256. SHRI ARVIND GANESH KULKARNI; SHRIMATI PRATIMA BOSE: Will the Minister of DEFENCE be pleased to state:

(a) whether Government's attention has been drawn to the effect that Government desire to sell nearly 1.5 million pieces of light, medium and heavy armaments now rusting in va-riou<sub>s</sub> parts of th<sub>e</sub> country;

(b) whether Government have also seen the reports in press of high level corruption where Mr. Michell who was agent to fix the deal has passed on huge sum<sub>s</sub> to Defence Officers and other concerned.

(c) if s<sub>o</sub>, the details in this regard;

(d) whether Government have investigated or propose to investigate into the allegations; and

(e) whether the Defence Officers who opposed thi<sub>s</sub> sale were transferred from their places of posting to different places?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) Yes, Sir. Certain light, medium and heavy armament items are declared obsolete or obsolescent from time to time following well established procedure and detailed scrutiny at appropriate levels. They are inspected at laid down intervals to ensure that they are stored in conditions a<sub>s</sub> prescribed in various regulations

(b) to (e) No, sir. There were some press, reports about negotiations for sale of Centuria<sub>n</sub> tanks through Mr. Michell. The negotiations were called off by the Government in early June, 1980.
