Pigmy Deposit Collectors in Banks

1497. SHRI SUNDER SINGH BHANDARI: Will the Minister of LABOUR be pleased to state:

- (a) whether it is a fact that over 2 lakh persons are working as Pigmy Deposit Collectors in various Scheduled, Non-Scheduled and Cooperative Banks;
- (b) what are the protective laws for their Leave, Provident Fund and Minimum Wages; and
- (c) whether the Sales Promotion Employees (Conditions of Service) Act, 1976 has not been made applicable to them?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI P. VENKATA REDDY): (a) and (b) Government is collecting the information and it will be furnished as soon as it is made available.

(c) The Sales Promotion Employees (Conditions of Service) Act, 1976 at present applies only to employees in the pharmaceutical industry. The suggestion for extending that Act to Sales Promoion Employees engaged in other industries has been taken note of by the Government.

1498. SHRI NAGESWAR PRASAD SHAHI: Will the Minister of LABOUR be pleased to state the number of lock-outs and strikes in the country during the period from 1st January, 1980 to 31st October, 1980, the num-

ber during the same period in the previous year and the number of mandays lost due to these lock-outs and strikes this year?

VENKATA REDDY): According to the available provisional information, there were 1783 lock-outs and strikes during January to September, 1980 as against 2431 in the corresponding period of the last year. The number of man-days lost due to lock-outs and strikes during January to September, 1980 was 9.89 million (Provisional). Similar information for the month of October, 1980 is not yet available.]

Opening of Sub-Regional Provident Fund Commissioner's Office at Muzaffarpur

- (a) whether Government are aware of the inconvenience caused to the worker_S employed in the large number of factories in North Bihar, covered by he P.F. Scheme in visiting regional P.F. Commissioner's office at Patna for attending proceedings under section 7A and 14B of the Act, including petty matters; and
- (b) if so, whether Government propose to open a sub-regional office of the Provident Fund Commissioner

at Muzaffarpur in the mear future with a view to mitigate the inconvenience to the employers and workers, if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI P. VENKATA REDDY): (a) Yes, Sir.

(b) The provident fund authorities have reported that the proposal for opening of a Sub-Regional Office at Muzaffarpur, is under consideration and that it would be placed before the Central Board of Trustees at their next meeting.

- (a) whether the representation dated 27-7-80 has been received from West Bengal Tea Employees' Association, Jalpaiguri, for amendment of Payment of Gratuity Act, 1972 so as cover those employees with income upto Rs. 1000/_ under the scheme in view of the reduction in purchasing power of the rupee; and
- (b) if so, the steps proposed to be taken by Government in this regard?

(b) Various proposals for amendment of the Gratuity Act, 1972 including amendment of the salary limit are under consideration. The suggestion of the Association will be given consideration while taking decisions on the proposals.
