(d) whether injured workmen have received compensation from the E.C L. authorities and if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI P." VENKATA REDDY): (a) Yes, Sir. Enquiries by officers of Directorate General of Mines Safety revealed that, in addition, the winding engine driver was also responsible for the accident.

(b) The accident occurred when the speed of a cage in which ten per sons were being lowered could not be controlled by the winding engine driver. The down-going cage landed hard on the pit bottom platform and four persons sustained serious inju The remaining six ries persons received minor injuries.

The following persons have been held responsible for the accident:

- 1. Shri R. P. Singh, Agent.
- 2. Shri S. N. Singh, Manager.
- 3. Shri R. N. Roy, Engineer.
- 4. Shri B. P. Das, Junior Engineer.
- 5. Shri N C. Mondal, Windlag gine Operator.
- (c) Explanations were called for by the D.G.M.S from all the officials held responsible and their replies are being processed. The management have also called for explanations of Engineer and Winding Engine Operator.
- (d) The management is computing compensation amounts payable under the Workmen's Compensation Act.

- (b) if so, the details of the representation;
- (c) the number of coal mines of the E.C.L. wherein the managements have entered into contracts with contractors for removal of overburden and details thereof with names ^{OI} mines and terms of contracts and payment made in each
- (d) the names pi such contractors and when the contracts were signed;
- (e) what steps Government have taken against the E.C.L. management for such gross violations; and
- (f) if the reply to part (a) above be in the negative, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI P. VENKATA REDDY); (a) Yes, Sir.

- (b) The representation related to the alleged violations of the Govern ment's Notification dated the 1st 1M»ruary, 19T5, prohibiting employment of contract labour in overburden re moval and earth cutting in coal mines. The allegation w_{as} that the coal mines, especially those under the Eastern Coalfields Limited, have been engag ing contract labour in overburden removal and earth cutting etc. and have been hiring heavy earth moving machineries with operators from pri vate parties—thereby violating above Notification.
