# Supply of bulk drugs by IDPL

1680. SHRI KRISHNA NAND JOSHI: Will the Minister of PETRO-LEUM, CHEMICALS AND FERTI-LIZERS be pleased to state:

- (a) whether it is a fact that the IDPL have not supplied any bulk drug, whether canalised or non-canalised, to the actual users for the last six months;
- (b) what are the names of the units to whom supplies have not been effected by IDPL and whether this action of IDPL is not punishable under the Essential Commodities Act; and
- (c) what action has been taken by Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM, CHEMI-CALS AND FERTILIZERS (SHRI DALEIR SINGH): (a) and (b) IDPL have reported that they had to curtail/ suspend supplies of some bulk drugs for sometime to the actual users as production thereof was affected due to frequent power cuts, disruption in water supply and non-availability of certain inputs etc. IDPL have further reported that supplies are now being effected barring a few items to the formulators keeping in view availability.

(c) Whenever specific complaints about non-supply of bulk drugs by IDPL are received, Government takes up these with IDPL for expediting their releases.
