(to) Steel Authority of India Limited as a canalizing agency, have imported 21.589 tonnes of prime tin plates during the year 1979-80 at an average price of Rs. 5445/- per tonne (C. & F.) and during the current year, upto November, 1980, they have placed orders for import of 21,829 tonnes of prime tin plates at an average price of Rs. 5992/-per tonne (C. and P.).

(c) Indigenous production of tin plates is distributed to the consuming units on the basis of a formula approved by the Tin plates Producers Consultative Committee which takes into accounts, the past off-take and capacity of unit. Imports are, how ever, made on back to back basis; that is against specific-requirements registered by individual units.
