#### **Production of Khadi**

#### \*332. SHRI GURUDEV GUPTA:

# SHRIMATI HAMIDA HABI-BULLAH:

Will the Minister of RURAL RE-CONSTRUCTION be pleased to state:

(a) whether it is a fact that some States such as Uttar Pradesh and Madhya Pradesh are lagging behind in the production of Khadi;

(b) if so, what are the reasons therefor: and

(c) what steps Government have taken to ensure rapid growth of Khadi and Village Industries in a planned manner in these States?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRI BALESHWAR RAM): (a) and (b). Uttar Pradesh occupies the top position in Khadi production and accounts for about 22 per cent of the total production of khadi in the country. In the case of Madhya Pradesh there was a marginal decline in Khadi production in the year 1977-78, but the production picked up in 1979-80. The Khadi production, in terms of value and meterage, has shown increasing trend except in the year 1975-76.

(c) It is proposed to step up distribution of improved tools and equipment and to accelerate training facilities in these States. Khadi and village industries will be promoted in all the development blocks and the resources available under Integrated Rural Development programme will be utilised for the purpose. Required financial, technical, raw materials and marketing support will also be provided.

**†[THE MINISTER OF STATE IN** THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRI BALESHWAR RAM): (a) The Khadi & Village Industries Commission has to repay Rs. 251.65 crores to the Government and Rs. 3 crores to other financial institutions. The total investment made by the Commission as on 31-3-1980 was Rs. 249.80 crores. There was an accumulated surplus of Rs. 37.28 lakhs under Village Industries and an accumulated loss of Rs. 10.19 lakhs under Khadi under the departmental activities run by the Commission as on 31-3-1980.

(b) A Conference of Commonwealth Science Council delegates was arranged by the KVIC during the last three months. The total expenditure incurred on it was Rs. 6,647.00 only. No liquor was served in that Conference.].

#### Development of Shantivana

#### \*334. SHRI DHARAMCHAND JAIN:

Will the Minister of WORKS AND HOUSING be pleased to state:

(a) what are the plans for further development of Shantivana and areas around it in Delhi during the next two years;

(b) whether it is a fact that the artificial canal developed near Delhi Gate with a view to beautify the area around Shantivana has become a breeding ground for mosquitoes; and

(c) if so, what are the reasons for not releasing water in the said canal?

THE MINISTER OF PARLIAMEN-TARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) No definite plans have yet been formulated. The Shantivana Committee is seized of the matter.

(b) and (c). The canal which is not in the immediate vicinity of Shantivana generally remains dry, throughout the year. As and when water is found to be stagnating, it is treated with larvicides to ensure that mosquitoes do not breed.
