**Assessment of House Tax for
LIG Flats, in Rajouri Garden**

Municipal Corporation of Delhi
have reported that the assesseees of LIG, DDA flats, Rajouri Garden, near Hari Nagar Clock Tower, had sent representation demanding that their flats should be assessed on a lower rental value as had been done in the case of Janakpuri flats. But it has not been possible to accede to their request because according to the recent judgement of the Supreme Court rental value of the properties in Delhi should be fixed on the basis of Standard Rent determinable on the principles laid down in the Delhi Rent Control Act, 1958. Rental value of DDA flats in Janakpuri area

which had been fixed at lower rates on account of under-development of the area has since been enhanced on the basis of Standard Rent/cost of flat with effect from 1-4-78. The assessment of LIG flats of Rajouri Garden has accordingly been proposed on the basis of Standard Rent.

Payment of arrears of increased house rent allowance to Delhi Police

However, the allegations of corruption in the sale of films are being investigated by the Central Bureau of Investigation.

The question of taking action will only arise after these investigations are completed and the results made available.
