(c) if so, what are the details thereof and what action Government have taken against the S.H.O. and other staff?

(b) and (c) Some workers of a political Party had staged a demonstration for an hour on the 27th October, 1980 near Gopi Nath Bazar, Delhi Cantt. They were carrying banners "Chhavani Police Ko Congress-I Ke Changul Se Mukht Karo—Congress I Ke Jhoote Ishare Par Banaye Gaye Muquidme Vapis lo" etc. The demonstration was political in nature. The question of taking action against the S.H.O. and other staff, therefore, does not arise.

**British Navy Caught spying in
Bombay Docks**

(b) and (c) Two Sailors (Civil Crew) of the auxiliary ship Olwen of the British Navy were found taking photographs inside the Naval Dockyard at Bombay on the 6th November, 1980. The sailors were apprehended by the security staff and taken for questioning. Later, an officer of the auxiliary ship Olwen
