THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA) : (a) and (b) A State-wise statement indicating the amounts of reimbursement made under the Central Investment Subsidy Scheme and Transport Subsidy Scheme since 1970-71 to 1979-80 is enclosed. Under the Central Investment Subsidy Scheme 1080 industrial units have come up in the backward areas since the inception of the Scheme upto 30-6-1978.

Under the IDBI's assistance to backward areas an amount of Rs. 1731.7 crores has been sanctioned to 54,889 units since 1970-71 upto June, 1980.
