Reported statement of Shri Jaswant Singh, Leader of the opposition, Rajya Sabha

SHRI V. NARAYANSAMY (Pondicherry): Hon. Chairman, Sir, I would like to raise a very important issue for which I gave notice. The issue is relating to the statement by the hon. Leader of the Opposition that in 1995, information came to him that there was a mole in the Prime Minister's Office. Sir, I respect the Leader of the Opposition. He was the former Deputy Leader of the Lok Sabha. He was the former Defence Minister, External Affairs Minister and Finance Minister of this country during Vajpayeeji's regime; and now he is the Leader of the Opposition in this august House. And, he is the Leader of the Opposition in this august House. Several interviews were given by him in the print and the electronic media, wherein he stated that he came into possession of a document of an American diplomat written to a Senator—not named—

through which he came to know that there was a mole in the Prime Minister's Office. And, the nuclear secrets of this country, when Shri P.V. Naramsimha Rao was the Prime Minister of this country. Leaked to the USA. This is a very serious allegation. This is concerning the national security of the country. Therefore, a demand was made not only in this House but also in the public to name the mole. Who is that person? He is giving several versions in several interviews. In one interview he said that he was a civil servant. Secondly, he said he retired from service. Thirdly, he said, 'I don't know whether he is a civil servant.' Again, he said that he has gone and settled in the USA. Sir, a person, who has been working in the Prime Minister's Office and leaking the vital nuclear information of this country to the USA, is *desh drohi*. Being a responsible Leader of this House and after holding several positions, was it not his duty to bring it to the notice of the then Prime Minister of this country? Not only this, even after that, when his Prime Minister was holding office, he was Minister. Why did he not convey this to hon. Vajpayeeji when he was the Prime Minister of this country? What made him to disclose only about the mole, that too after ten years? What is the necessity for him to tell this House now? He was a leader. Why he had not disclosed it in 1995 itself? I do not want to cast aspersions on anybody. I would like to know about this. Sir, he also said that he would disclose it to the hon. Prime Minister. I could see from the reports that he has not named the mole even in the letter written to the hon. Prime Minister. According to media reports, it was not signed. It was on a white paper. Nothing was there in that document. The whole country wants to know who is that person. Who is that mole? I want to know that.

SHRI JASWANT SINGH: Mr. Chairman, Sir, I had submitted yesterday that as the subject was serious, the hon. Members recognising the serious import of the subject, if I am permitted to say that I have to in relative—I say, 'relative'—relative peace in the House, I think, we would better subserve the subject and, then, this kind of rather intemperate interventions.

Sir, I must, at the very outset, clear the misconception whatever it is that I have to do is to dispel the notion about the names. Let me go paragraph by paragraph of the note that I had submitted to the hon. Prime Minister on the 29th, or, 28th, I will come to that in a minute.

In paragraph one, are the names of both the sender of this note and the recipient. The sender is one Mr. Thomas Graham, and the recipient is Mr. Harry Barnes. The subject is 'India nuclear testing—deployment of Prithvi and other steps'. Thereafter, the very opening sentence that Mr. Graham chooses to employ. My eyesight has gone a bit weaker since earlier times. So, you should render help. Thomas Graham is recommending, "Please treat this as a NODIS/Chetokee." These are security classifications used by the United States of America. "At this stage, please do not show this to President Carter." This is name one. "I have not shown it to Peter Goldmark." This is name two. And it goes on. It says, "I need your advice on how to proceed." It says, "...might be able to get through to people like Talbott as to the serious nature of this information." In paragraph 2 itself, Sir, it says, "the credibility of the messenger is crucial." In paragraph 3, he says, "We will have to choose

between respecting the confidence of a person with direct access to Prime Minister Rao who in the past has helped diffuse pressure to resume nuclear testing *versus* informing Secretary of Defence Perry, Secretary of State Christopher, and President Clinton..." And he goes on to say, "The senior person I talked to swore me to secrecy as he departed for a secret meeting in Bangalore where the issue of nuclear testing will be put before the Prime Minister by a majority of his advisors who favour this step. He was very concerned that he might not win this battle, but he did not want me to share this information with anyone at this time. He feared the consequences of a leak." The paragraph goes on, Sir. I will not go into that.

Then, after that, there is the fourth paragraph. "Prime Minister Rao has called a super secret meeting to be held in Bangalore to debate whether India should resume nuclear testing, deploy the Prithvi missile and take "other steps." (I did not get a chance—he says, Mr. Graham,—to probe what this last phrase means)". In this paragraph itself, Sir, there are certain names. Mr. Graham says, "The meeting is being held in Bangalore to avoid any leaks, either to the Americans, BJP, or to the growing number of Indian hawks..." "Participants will include the Prime Minister, senior officials from the PMO. (I did not ask who because I had limited time talking with him outside of ear shot of others)." Then, he says, "Chidambaram, Head of the Atomic Energy Commission and leading advocate of nuclear testing, Abdul Kalam, Head of DRDO and leading advocate of deploying the Prithvi Missile, Raja Ramanna, designer of 1974 tests and swing vote if the issue focus on technical need to test, Naresh Chandra, who is trying to provide the Prime Minister with informed views counter to those being advocated by the ministries. The serious nature of this meeting was so clear (and it is second such one in a month at the Prime Minister's level when these issues were debated). Then the paragraph goes on.

Then there is a paragraph 5 which talks of the possible responses that could be given to this, and he inquires from Harry Barnes, who has been earlier an ambassador there, "whether I should talk to McNamara. Because McNamara, he suggests, "could ask for a meeting with Bill Clinton." "He said explicitly that Robin Raphael was seen in India as ineffective, a person who did not understand the level of hatred for her in

India." And, he goes into some details. Then, there is a suggestion again to facilitate this by the author when he says, "When I raised the possibility that Australian Prime Minister Keating might help formulate a new geo-political coalition of States to really push for abolition." ...of States to really push for abolition—this is abolition on nuclear arms— that is why, Sir, it continues to emphasise the seriousness of this. In paragraph seven, which I refer to, thereafter, again the relevant portion is about a possible visit—a proposed visit of the then Head of the Atomic Energy Commission, and he does say that, "Dr. Chidambaram was extremely upset because a restriction was placed upon his visit then. And I said that I understood the issue was that Mr. Chidambaram wanted to come only if an agreement could be signed, but one on nuclear safety, was out of the question." And, here, Sir, on the question of nuclear arms which the hon. Member, Shri Shahid Siddiqui has mentioned, he volunteered the informant that there were several sources of pressure on the then Prime Minister, and he goes on to elucidate a particular article that was then written in the journal of the IDSA. Then, some assessment; some speculation on the aegis of Dr. Chidambaram and Dr. Abdul Kalam respectively when how he thought that the younger scientist in each of the establishments was not as hawkish as these two, etc. There are certain elements that come in and the informant is sharing with Mr. Graham; that is why he has been called upon to argue the other side which is the non-testing side. The fifth element was an assumption that elements associated with the ISI are already extremely powerful, and that brings in the Pakistan aspect; there is considerable degree of these things after this discussion and there is a second informant, I had an hour-long debate, heated argument with a more junior official, official who had obviously been doing serious thinking, and it goes on to the details of that serious thinking ...*(Interruptions)*...

SHRI V. NARAYANASAMY: Sir, I want to put a straight question ...*(Interruptions)*...

MR. CHAIRMAN: Please take your seat ...*(Interruptions)*... Don't disturb ...*(Interruptions)*... Your question will be replied. ...*(Interruptions)*... Your question will be replied.

SHRI JASWANT SINGH: Sir, I am not reading out the whole thing. And, then, Sir, at the appropriate stage, I request your permission to

place this on the Table of the House, but let me come to that. This person says, Mr. Graham participated in the Bangalore conference where he had been an advocate of incremental steps including placing some Indian reactors under safeguards. So, we, hear a ...*(Interruptions)*...

SHRIMATI BRINDA KARAT (West Bengal): Why didn't he inform then?
...*(Interruptions)*...

SHRI JASWANT SINGH: Now, there is a discussion, thereafter, in terms of costs, and such aspects. There is also a discussion on the possible reactions with OECD countries and how the Canadian Prime Minister who had been asked to be the Chief Guest at the Republic Day parade of 1996; and, thereafter, the Government of Canada had pressed India not to test and deploy the Prithvi Missile and also—because that has been, consistently, the Canadian stand to join the NPT, the invitation was withdrawn. That was also the period when ENRON was being negotiated, and that generated a great deal of discontent within the country. And this goes on, I won't read the whole thing. Then, there is a discussion here on the question of a Comprehensive Test Ban, and the person, with whom Mr. Graham speaking is, discounted the importance of a Comprehensive Test Ban which he asserted will have the same membership as the NPT, and thus be worthless and he goes on to analyse this. Then, there is also, Sir, relevantly.... and in the context of today that I said, 'these was fourth order issues after the pace of the peace process, Israel perceptions of Iran's nuclear programme, and Israel-US relations.' And, here again, we find that what was being put across in 1995 by the United States of America is what is still being put across by the United States of America. And, there is a discussion about how China would react, and also on France and, thereafter, Sir, the document goes on to talk of other things. He analyses that 'the bottom line is that there is a serious debate, the psychology in Delhi seems to be that they have "little to loose", even if Rao does not approve resumed nuclear testing, I would be surprised if his opponents would keep this decision quite. There is a significant change that saving into the Americans will become a major electoral issue, and the BJP in their Election Manifesto announced that. Then, there he goes into the issues for decision. That is here, Sir. I do want to prove that; there is sufficient here by way of name.

The other observation that was given to me by the Prime Minister's letter, let me cite, Sir, is that there it is said, "this does not come under a

letterhead, and this has not got the signature." I am somewhat surprised by this observation, Sir. The intelligence sources do not give whatever they have to give by way of letterheads, and they do not sign everything. That is why you have an aspect of intelligence assessment. Now, where does this whole thing begin, Sir? The thing begins out of a book that I have written and out of 400-odd pages, only one page in that really relates to this aspect, and I want to read parts of it only because to emphasise the context and the relevance in which this issue was quoted by me as I have quoted, only in part. I quote, "I had started, really, by explaining all the measures that had to be taken to safeguard the secrecy of the tests. Brajesh Mishra, then Principal Secretary to the Prime Minister, is to be credited that this was achieved so irreproachably. The aspect of security was, primarily, his responsibility. But the search for information was real, it was relentless, very intrusive and had been going on for long," And, there I cite, "In 1995, for example,..." and I will state, this is when—now, I will not go into details. Sir, I won't read out the whole thing because it is all here and I don't wish to take much time of the House. Then I conclude by saying, 'it was vital for India that total secrecy be maintained. For another, this note emphasises how the United States and its allies considered this issue, also that there was 'awareness', in the summer of 1998, about developments that could take place with the BJP in office. That is why I took with a certain degree of scepticism, the theory about the objectives of the United States, with whom I was engaged in meeting the requirements of that country, was to somehow, anyhow prevent India from testing. Sir, I have earlier given the examples on that. Now, how is the sequence of this? On 24th or so,—the 21st the book was on the bookstands,—I think, the hon. Prime Minister was perhaps asked a question about this or what. I don't know where he was asked. Thereafter, he said, he found that, the words to that effect, that I lacked decency, and I was deficient of courage. I find, Sir, that this statement was certainly unwarranted. It was, in my view, unworthy, and it was gratuitously insulting. Now, so far as the sequence of events is concerned, after the Prime Minister had said this on the 24th, I wrote a letter to the Prime Minister on the 25th, which, I may be permitted to quote. No, I had my Secretary call the Prime Minister's Private Secretary to seek time for me to go and meet him; I could have shared all this and explained all this to him. The Private Secretary of the Prime Minister informed my Secretary— 'we will give you time within five minutes: I will come back to you within

five minutes'. Five minutes turned into five hours. I think, after a lapse of about 60- hours or so, I wrote to the Prime Minister and I told Dr. Manmohan Singh, 'In response to your recent remarks in the media, my Secretary had, on 25th July, in the forenoon, conveyed a request to your Private Secretary about an appointment with you. I wanted then to hand over to you papers in connection with an 'informant' in the PMO' -the word has not come here—in the mid 1990s. As there was no response after more than 60 hours, this request was repeated and in writing. I have still to hear from you or your office about this meeting. I am led, therefore, to the conclusion that you are perhaps disinclined to meeting me. To save you any discomfiture I am sending by hand through my Secretary all the relevant papers.' In between my Secretary had written to the Private Secretary also and on the 28th, I sent all the papers. On the 29th Sir, the hon., the Prime Minister chose to reply me. He said it is not for me to reply.

I have an observation to share with you, Sir, and also with all hon. Members. It is, of course, up to the Prime Minister how he chooses to reply a Member of Parliament. But, I do request the Prime Minister to reflect on the manner in which he chose to have the reply communicated. If the Prime Minister of the country chooses to have a letter that has been written by a 'Jaswant Singh' and do the way he did, I think it would entirely be a matter of no consequence, because I am quite accustomed to this kind of treatment. But I do, Sir, hold a position in the House and in Parliament and also within my party. I don't say it for any other reason, but where I am today, Dr. Manmohan Singh has been for several years, when, as things happened, I was leader of the House. These are the altering circumstances of time and situations. I did not, on even one single occasion, ever, in any fashion whatsoever, so conduct either the business of the House or my behaviour, to cause any, or show any, direct or indirect response to the Prime Minister. This is including one occasion when I made a request to my senior, who is today the Leader of the Opposition in Lok Sabha; the then Leader of the Opposition, Dr. Manmohan Singh, was aggrieved about something that he had said as the then Home Minister. And he did convey his regrets and apologies to Dr. Manmohan Singh. Not once did we directly or indirectly show any disrespect to the office or to the person.

Sir I do object, after that unwarranted and gratuitous insult about

calling me lacking in decency and in courage, to go to the extent of the having my letter to the Prime Minister replied by his Press Advisor directly to the Press, even before I have received it. This is, for all of us, Sir, particularly you and the Prime Minister, to reflect if that is how the Opposition is to be treated. The letter from the Prime Minister said that it is not in original. I am intrigued because I will be submitting this, and I think, this has been shared with the Press. It is said that it is not an original, has no signature or letterhead. Now, I must answer this. Of course, I am not the recipient; I am not Harry Barnes, I am not in the mailing list of Thomas Graham, and, therefore, I am hardly likely to get a signed copy. How can all information of this nature be on a letterhead? And, I found it, if I might put it, somewhat irrelevant and facetious that the question of letterhead and signature ought to be raised as an objection by the hon. the Prime Minister. Then, there is an information, "alleged informant is not named nor is there any confirmation that the person was from PMO." Sir, that is for the Prime Minister to judge because then, I replied to him on the 31st itself, because I was not in Delhi when my office received the PM's letter and it was first conveyed to me through his Press Advisor. I did say "I received your letter of July 29, 2006, last evening upon my return from Mumbai. Before that, your Press Advisor had already shared its contents with the media. What is implied in the contents of your letter about a weekly magazine's report is not relevant to what I sent to you. All such information, as I had in my possession, has been shared fully. If you consider that the issue merits further investigation, that will be for you to decide. If in your reckoning, it is not of sufficient import, that too is your judgement, though that is not consistent with your earlier personal comments about me. I also added, Sir, "You have considered it fit to render some advice to me, though your simultaneous expression of disinterest in the matter makes the approach somewhat unfocussed." Now what is the advice? What is the question that has been raised by both Shahid Siddiqui Saheb and Thiru Narayanasarthy. The issue, Sir, in 1995, 1996, 1997 was really about the Test Ban Treaty, the Comprehensive Test Ban Treaty. We, in 1995, with the indefinite extension of the NPT, the question that prominently faced India as a challenge, was the question of CTBT. As you know, Sir, or those who are students of these matters, know and it has been reported also that Dr. Manmohan Singh, when he was Finance Minister to Prime Minister Rao, was opposed to the nuclear testing by India and he had

grounds which he can certainly hold that those were not beneficial to India on the grounds of economic consequences, etc. He is welcome to hold those views and if he continues to hold those views, even now, he is welcome to hold those views ...*(Interruptions)*

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PAWAN KUMAR BANSAL): It is totally extraneous.

SHRI JASWANT SINGH: It is very irrelevant. In 1995, what happened. ...*(Interruptions)*.

DR. MANMOHAN SINGH: What is the relevance of what. ...*(Interruptions)*.

SHRI JASWANT SINGH: I will tell you the relevance.

SHRI PAWAN KUMAR BANSAL: It is totally extraneous matter. Talking about financial consequences is a totally extraneous matter.

SHRI JASWANT SINGH: In 1995, it has been said, Sir, ...*(Interruptions)*.

SHRI V. NARAYANASAMY: I have been hearing for the last 45 minutes. The Leader of the Opposition has not so far named ...*(Interruptions)*.

That is also a fact because in December, 1995, the New York Times, in fact, published a story. Those of you who pursue such matters and study would know that satellite surveillance by the United States of America had established that boreholes were being dug in the Pokhran region. That was an additional factor to bring pressure. Again, Sir, what was the context and relevance was the imminence of CTBT. We had reached the autumn of 1995. It was a principal policy objective of the democratic Government then in the United States of America to 'somehow, anyhow'.... That is why, I said that the surveillance on India was very intrusive. Thereafter, Sir, in 1997, a series of things happened. Sir, in 1996, we were temporarily in office for about 13 days or so. (*Interruptions*) In 1997, Sir, threats, as I have brought out, were brought out in an expose in a newspaper actually on the 20th September, 1997 and it headlined the expose with the heading: US Plots Gujral-Sharif Show. What was the attempt then by the United States of America, Sir? The United States of America wished to bring pressure on the then Prime Minister because the then Prime Minister was visiting the United States of America to attend the UN General Assembly. And he was, I think, then also the Minister of External Affairs to somehow have a kind of an Asian or South-Asian Camp David between the then President Bill Clinton, and to control and to brine) a curb. (*Interruptions*) Thereafter, Sir, this very document, this very fact that I am now talking of, this very fact about Mr. Graham and the communication that Mr. Graham had with the Ambassador Harry Barnes was reached to the then Prime Minister in time so as to caution him what the United States of America was all about. In 1998, Sir, when we

Minister of State conducts the proceedings of their own interventions in the fashion that they do. That is their choice, Sir. I am attempting to the best of my ability to answer, and I was answering as to what we did when the information came into our possession ...**(Interruptions)**.

SHRI JASWANT SINGH: Sir, we assessed .^(interruptions)...

SHRI JASWANT SINGH: I want to make it clear. ...*(Interruptions)*...

I wanted to know from the Leader of the Opposition who was that mole, who was that spy who leaked the information to the United States of America ...*(Interruptions)*... The Prime Minister is here, and you kindly tell the name. ...*(Interruptions)*... I agree with ...*(Interruptions)*... It is not at all relevant ...*(Interruptions)*...

SHRI JASWANT SINGH: I don't need any prompting, Sir, ...*(Interruptions)*... I don't need any prompting I am well aware of what I am doing. In fact, the manner is which, sometimes, the Treasury Benches are conducting themselves, as if this is not a House, but ...*(Interruptions)*...

SHRI SANTOSH BAGRODIA: Only Treasury Benches are conducting? No, this is not fair. This is not correct. Why don't you look at your own faults? ...*(Interruptions)*...

We are discussing a serious subject and I am doing the best that I can to answer all these questions. What you said is...*(Interruptions)*... It is a very sad demonstration, Sir, of the ruling arrangement, impatient and intolerance, both, I wish to submit, Sir that ...*(Interruptions)*...

SHRI JANARDHANA POOJARY (Karnataka): We would like to know whether there is any mole...*(Interruptions)*... Tell us whether you are going to name the mole. Where is the mole? ...*(Interruptions)*...

SHRI JASWANT SINGH: Sir, in 1997, the matter became public again, and all the aspects of it became public. The efforts of the United States were thwarted. The efforts made by the United States, as in 1995, Sir, because information had been leaked from the then Prime Minister's Office, the plans to hold a nuclear test was leaked. When it came to our possession...

SHRI V. NARAYANASAMY: By whom? ...*(Interruptions)*...

SHRI JASWANTSINGH: Please, if you sit down ...*(Interruptions)*... If you were to sit down ...*(Interruptions)*... Sir, in 1998, the principal challenge before India, before the Government was to somehow ...*(Interruptions)*... Sir, they were asking me what we did with it. In 1998, we had to ensure that before anything else is done, we conduct the tests; and we conducted the tests within two months of coming into office without the ...*(Interruptions)*... That was the objective. The principal task ...*(Interruptions)*... Now, I cannot yield, Sir ...*(Interruptions)*... Sir, they keep asking me, so many times, just now in the last few minutes, now you keep telling me ...*(Interruptions)*...

SHRI ANAND SHARMA: We want an answer. Who was that in the then Prime Minister's Office? Mr. Chairman, Sir, the House has the right to know it. You have to answer. Mr. Chairman, Sir, this is not an answer. ...*(Interruptions)*...

SHRI JASWANT SINGH: Mr. Chairman, Sir, I am grateful to you. You have been very patient. I cannot say that the Treasury Benches have been equally patient. But I will endeavour to, now, limit my intervention, Sir, what remains of it. There were principally three questions, if you read within the parameters of three — the names, who, etc. And the second was, Sir, what did we in NDA do and the third was really the nuclear aspect. I understand that the nuclear is the larger question and the nuclear has also come up under a separate discussion. If I may be permitted to say — I will conclude very shortly, Sir, I will finish within the time that you have allotted — So far as nuclear is concerned, the central purpose of the United States of America in all this that I have submitted, in the documents that I have shared, in what I have said in the House, was, to somehow, restrain India from going down the path of attaining the position of Nuclear Weapon State. Nuclear Weapon State or not is a technicality. But India is a nuclear weapon possessing country. And it is because of that all this effort was made by the United States of America. That was their aim, Sir. And, we addressed, as Government, as the NDA, this challenge. It was because I was asked, "what did you do?" There was the fact that a piece of paper, a document, information was in my possession. Having assessed that and having realised that in the year 1997 it had already been made public, it had already been-given to the then Prime Minister, it was already, therefore, in the Prime Minister's Office, because Prime Minister's continuing function, then, in 1998, the single responsibility and challenge that we had, as the Government, was to defeat the purpose of that and all the effort that the United States was doing. There were two ways in which we could have done it. We could either have ordered a detailed, vindictive or an exploratory inquiry. The people concerned, Mr. Graham/ was already out of the country. He is not an Indian citizen. Ambassador Harry Barnes

was not living in India. What was clear was the direction in which those that were in the knowledge of this information, they were in the then Prime Minister's Office. They used that knowledge to somehow prevent India from conducting its nuclear test. Therefore, the first responsibility we had, as NDA Government, was to defeat the American purpose of restraining India. That was the first challenge. Everything else follows.

SHRI V. NARAYANASAMY: Allowing the spy to continue to work and share the nuclear secrets with the USAI That was the success of the NDA Government!

MR. CHAIRMAN Please take your seat.

SHRI JASWANT SINGH: Sir, the second thing what we did is this. I will conclude within 20 minutes. The third really related to what Shri Shahid Siddiqui has said about the consequences of India's nuclear programme.

One consequence was immediate that, in the year 1995 or 1997, the attainment by India of a nuclear capability, also weapons capability, could not be achieved. That is not even open to question. What caused it, amongst other factors, but, which, certainly caused, was that the vital information in this regard was reached to the USA, the State Department and the White House ...*(Interruptions)*...

SHRI V. NARAYANASAMY: By whom?

SHRI JASWANT SINGH: I have said by whom. I will come back to it in a minute ...*(Interruptions)*...

SHRI V. NARAYANASAMY: That is the question ...*(Interruptions)*... That is the moot question ...*(Interruptions)*...

MR, CHAIRMAN: Please let him say ...*(Interruptions)*...

SHRIMATI SUSHMA SWARAJ: Please have some patience ...*(Interruptions)*... The hon. Leader of the Opposition says that he will come to it in a minute ...*(Interruptions)*... Cannot you have patience to wait even for a minute? ...*(Interruptions)*...

SHRI V. NARAYANASAMY: Madam, we have been sitting patiently for two hours ...*(Interruptions)*...

SHRI RAVI SHANKAR PRASAD: So what? ...*(Interruption)*...

SHRI JASWANT SINGH: Sir, I will be very brief on the nuclear aspect. From the USA, the pressure upon India was about the Test Ban, about subscription to the Fissile Material Treaty, about falling in line with the larger, global American aims on the question of nuclear weapons. That has relevance. That has a continuing relevance. And, it has a continuing relevance. Sir, let me cite just one or two examples. I would not go into all these in detail. In any event, there ought to be, and I am given to understand by Smt. Sushma Swaraj, who so ably and so assiduously helps me in the Parliamentary work and does much better than I could possibly do ...*(Interruptions)*...

SHRI SANTOSH BAGRODIA: Then you make her the Leader of the Opposition ...*(Interruptions)*...

SHRI JASWANT SINGH: She is welcome to take over from me if you feel that she will do a better job than me ...*(Interruptions)*... Sir, I come to the nuclear aspect. Why I say this is, if you just examine the conduct of this Government so far as the whole approach to the nuclear policy is concerned on July 18, 2005, for example, it was ten years after that attempt. What is happening is this. The point I am making is, the USA its approach, its intention and its purpose is fixed, constant, unchanged. They have not altered their views from what they were — whether it is Democratic Government or whether it is Republican Government. Principally, it is to put a restraint on India's nuclear capability, a restraint on India's fissile material production to somehow restrain even the Missile Programme of India. It is because of that I cite just two or three cautionary notes. My able colleague, Mr. Yashwant Sinha, has done a great deal of work in this regard. Let me cite just two or three examples to illustrate what I am saying. On July 18, 2005, a benchmark was established with the USA that it would amend its laws to end embargo against the nuclear trade with India. The Bill that has recently been enacted or the purpose clarified by the House of Representatives says, 'to permit only restrictive and conditional trade with India.' No waiver granted for India from all the provisions of Section 129 of the USA Atomic Energy Act.

Another example is, Sir, the USA pledges full Civil Nuclear Energy Cooperation and trade with India. What, actually, happens? The Bill now prohibits export of Uranium enrichment and spent fuel reprocessing equipment and technology to India. I wish to state one more example of this, which is the principal one. The hon. Prime Minister then informed us, through a statement that 'India will acquire the same benefits and advantages as other leading countries with advanced nuclear technology, such as the USA.' This was the statement, Sir. Violation is institutional discrimination against India. I have cited only 2 or 3. There has to be a separate discussion on this issue. I will conclude by saying that there were three parameters. Who is the person? I don't think it is very clear that those networks then in the know of what decision-making process is in the Prime Minister's Office, or from amongst them there is a person. The note is very clear in what it is saying. There is explicit, and there is also the implicit. The problem with the present Government is demonstrated by now the hon. Prime Minister has chosen to reply to my concerns. If the obvious should be denied because there is no signature, it is not on a letterhead. तो कई बार तो ऐसा लगता है कि अगर हम सिर भी काट देंगे तो कहेंगे कि टेढ़ा काट कर दिया है। It is a clear enough sign and points to then Prime Minister's Office. MR. CHAIRMAN: Your point will be answered. This much I can tell you ...*(Interruptions)*... please take your seat ...*(Interruptions)*... Your point will be answered ...*(Interruptions)*...

SHRI V. NARAYANASAMY: Since yesterday ...*(Interruptions)*... today also he is not ...*(Interruptions)*...

MR. CHAIRMAN: Please take your seat *...(Interruptions)...* Let him finish *...(Interruptions)...*

SHRI JASWANT SINGH: I spoke that I am repeatedly being asked, "Who is responsible?" It is this attitude which is responsible.. *...(Interruptions)...* There is the 'explicit' and there is the 'implicit'. What is explicit are the names to which I am *...(Interruptions)...* I received a letter from the hon. Prime Minister saying, "What is explicit is without a signature?" I have said, what is explicit *...(Interruptions)...* He said, "This is not under a letterhead." Even if after what is implicit and explicit, if after all the evidence and the evidence is the consequences of what happened because of all this what was planned to beateet by the 1895 Government could not be a test. Nothing more can. explicitly state as to the consequences of this Government's attitude. Then, what did we do, Sir, I will share with you in very brief, in two sentences. In the NDA, the Atal Bihari Vajpayee's Government defeated the purpose of the United States of America to shackle India *...(Interruptions)...* and to deny it *...(Interruptions)...* and to deny it *...(Interruptions)...*

SHRI JASWANT SINGH: We deny to the US its aim to shackle India's nuclear capability. *...(Interruptions)...* The third aspect *...(Interruptions)...* Shri Shahid Siddiqui sahab wanted to know what were the nuclear consequences. *...(Interruptions)...* The nuclear consequences are *...(Interruptions)...*

SHRI SANTOSH BAGRODIA: We don't want to listen to anything else. It is all useless *...(Interruptions)...*

MR. CHAIRMAN: Please take your seat *...(Interruptions)...*

MR. CHAIRMAN: Let him finish. ...*(Interruptions)*...

SHRI JASWANT SINGH: I conclude, Sir. ...*(Interruptions)*... I will conclude. ...*(Interruptions)*...

AN HON. MEMBER: He is saying today that the Government is compromising. ...*(Interruptions)*... No, it is not the case. ...*(Interruptions)*...

MR. CHAIRMAN: Let him finish ...*(Interruptions)*...

SHRI JASWANT SINGH: I appeal to the Treasury Benches ...*(Interruptions)*... I appeal to the Treasury Benches, in all seriousness. ...*(Interruptions)*... Please, hon. Member, Thiru Narayanasamy, may please sit down. ...*(Interruptions)*... Sir, I conclude. ...*(Interruptions)*... I appeal to the Treasury Benches, indeed, I appeal to all Members in the House, the question of the strategic autonomy of India is a vital question. ...*(Interruptions)*... He has addressed that question ...*(Interruptions)*...
