

(b) Due to the distribution of concessional white printing paper for printing of text books, the price of books so printed is comparatively low. However, as the supply of concessional paper is limited, full requirements of private publishers are not fully met, and some university level books and reference books have become costlier due to these having to use other varieties of paper.

(c) As most of the paper mills obtained stay orders with regard to the price of Rs. 3,785/- per tonne stipulated in the Price (Control) Order, 1979 for creamwave/laid paper, the said price become inoperative. The Order was however in force, particularly with regard to the stipulation of a statutory price for white printing paper. The prices of varieties of paper (other than concessional white printing paper) were showing an upward trend in the year 1979-80, due to increase in input costs, coupled with loss of production due to power cuts, shortage of coal etc. However, the market prices have stabilised in the recent past and are even showing a downward trend at present.

(d) Apart from encouraging domestic production, Government have arranged for supply of imported paper, through the marketing network of the Hindustan Paper Corporation, to cater to the requirements of printers and publish.
