for which the company suspended the production of these items which are also foreign exchange saver; and

(d) whether it is a fact that Gluconate Limited earned profit in 1976-77 which is a sufficient proof that it is a viable concern; if so, what are the reasons To_r not nationalising tins unit?

THE MINISTER OF STATE THE MINISTRY OF PETROLEUM, CHEMICALS AND **FERTILIZERS** (SHRI DALBIR SINGH): (a) M/s. Gluconate Limited was taken under Section 18AA of the Industries (Development & Regulation) Act on 22nd July. 1975. Government of West Bengal which had assumed the managerial and financial responsibility of the company, have been asked to furnish the proposal for the future set up of the Company taking into account the Government Policy on Sick Industries.

- (b) M/s. Gluconate Ltd. have informed that suspension of production of Pethidine Powder with effect from 15th October, 1980 wag on the grounds of hazards as the portions of the factory premises used for the production of Pethidine had been declared unsafe by experts and due to danger to life and property apprehended in case of continuity of production. They have also informed that the suspension of production of Pethidine had been approved by their Board and ratified by Government of West Bengal.
- (c) M/s. Gluconate Ltd. have informed that before take over by Government in 1975, the production of Proflavine at their existing site in Calcutta which is in thickly residential area was suspended on grounds

of hazard and shifted to Nagpur in Maharashtra where also the production Acriflavine was suspended consequent to an accident at Bombay in handling Nitrobenzene largely used in Acriflavine production. They have also informed that their Nagpur Unit was sold out by M/s. Gulconate Ltd. to a local firm in 1973-74 i.e. before the take over by the Government in 1975.

Comments/clarifications on the project features, cost estimates etc. are Sent to the Project authorities in batches and replies to these are awaited. The present position regarding these projects is given in the statement.

The inter-state aspects of this project are under consideration. Being a multipurpose project, the project would have to be cleared first by the Technical Advisory Committee of the Planning Commission, thereafter, power portion would be considered by the Central Electricity Authority.

4. Kuttiyadi Augmentation

The Project report examined in CEA/Central Water Commission and comments sent to the Project authorities. Further comments were sent in December, 79 and April, 80. Replies to these comments received in October, 80 are under examination. The Project involves westward diversion of waters of Karamanthodu river, a tributory of Kabini in Cauvery Basin, into Kuddiyadi basin to augment the power generation at the existing Kuttiyadi Power House. The inter-state aspects of the scheme are under consideration. The scheme would be considered for techno-economic clearance, after the inter-state issues are resolved and project features are finalised.

The Project report is under examination in Central Electricity Authority/Central Water Commission and Deptt. of Power.

- 6. Pandiar Punnapuzha tailrace.

The Project report has been examined. However, the scheme, as proposed, would utilise the regulated dis-charges of Pandiar Punnapuzha Hydro-electric scheme of Tamil Nadu, which has not been sanctioned so far. The Tamil Nadu Scheme involves interstate issues which are to be resolved before the scheme could be considered for clearance. The Pandiar Punnapuzha tailrace (Kerala) could be considered for clearance only after a decision on the implementation of the Tamil Nadu Scheme is taken.

The Project has been cleared by Central [Electricity Authority in Feb., 79. However, in view of the serious reservations expressed by Environmentalists and Ecologists all over the world, the matter is under re-examination.
