क्या पूर्ति तथा पुनर्वास मंत्री यह बताने
की कृपा करेंगे कि :

(क) क्या यह सच है कि 1971
के भारत-पाक युद्ध के दौरान सिंध से
विस्थापित होकर लगभग 8 हजार परिवार
भारत आये थे, जिनमें से लगभग 3 हजार
परिवारों का पुनर्वास अभी किया जाना है ;

(ख) क्या यह भी सच है कि
केन्द्रीय सरकार ने शेष सभी विस्थापित
व्यक्तियों का राजस्थान नहर परियोजना
में पुनर्वास करने के लिए राजस्थान सरकार
को लगभग 9 करोड़ रुपये का अनुदान
देना स्वीकार किया था ;

(ग) यदि हां, तो उसका ब्योरा
क्या है और इस सम्बन्ध में अब तक क्या
प्रगति हुई है ; और

(घ) इस पुनर्वास योजना का लागू
किये जाने का कार्य कब तक पूरा किये
जाने का विचार है ?

from Sind

DR. BHAI MAHAVIR:

Will the Minister of SUPPLY AND
REHABILITATION be pleased to
state:

(a) whether it is a fact that about
eight thousand displaced families
from Sind had crossed over to India
during the 1971 Indo-Pak war out of
which about 3 thousand families are
yet to be rehabilitated;

(b) whether it is also a fact that
the Central Government had agreed

to give grant of about nine crores of
rupees to the Rajasthan Government
for rehabilitation of all the remain-
ing displaced persons in the Rajas-
than Canal Project;

(c) if so, what are the details
thereof and the progress so far made
in this regard; and

(d) by when the implementation of
this Rehabilitation scheme is purposed
to be completed?

पूर्ति और पुनर्वास मंत्रालय में उपमंत्री
(श्री पी० के० थुंगन) : (क) जी हां,
राहत शिविरों में रखे गए 8600 विस्थापित
व्यक्ति परिवारों में से लगभग 4300 परिवारों
का पुनर्वास अभी किया जाना है, जिनमें से
3000 परिवारों का पुनर्वास राजस्थान नहर
परियोजना क्षेत्र में किया जाना है ।

(ख) जी, हां । (810.00 लाख
रुपए राज्य सरकार को सीधे ऋण के रूप
में और 90.00 लाख रुपए अनुदान के रूप
में) ।

(ग) प्रत्येक पात्र परिवार को लगभग
16 एकड़ भूमि के एक मुख्वा के
विकास की लागत आवंटित की जानी है ।
राज्य सरकार को प्रति परिवार 27,000
रुपए की दर से सीधा ऋण दिया जाना है जो
वह आसान किश्तों में विस्थापित व्यक्तियों
से वसूल करेगी ।

राज्य सरकार को 3000 रुपये प्रति
परिवार की दर से आधारभूत सुविधाएं
प्रदान करने हेतु अनुदान दिया जाना है ।

राज्य सरकार को 9.00 करोड़ रुपए
की पूरी राशि इन परिवारों को प्रति माह
राहत शिविरों से पुनर्वास स्थलों को भेजने को
दृष्टि में रखते हुए दी जाएगी ।

(घ) इन सभी 3000 विस्थापित
परिवारों को चालू वित्तीय वर्ष के अन्त तक
राजस्थान नहर परियोजना क्षेत्र में पुनर्वास
स्थलों को भेजने के लिए प्रयत्न किए जा
रहे हैं ।

†[THE DEPUTY MINISTER IN THE MINISTRY OF SUPPLY AND REHABILITATION (SHRI P. K. THUNGON): (a) Yes, Sir. Out of 8600 displaced person families admitted in relief camps about 4300 families are yet to be rehabilitated, out of which 3000 families are to be rehabilitated in Rajasthan Canal Project area.

(b) Yes, Sir. (Rs. 810.00 lakhs as direct loan to the State Government and Rs. 90.00 lakhs as Grant).

(c) Cost of development of one murabba of land measuring about 16 acres is to be allotted to each eligible family. A sum of Rs. 27,000 per family is to be advanced to the State Government as direct loan which in turn is to be recovered by them from the displaced persons in easy instalments.

Cost of providing infrastructural facilities @ Rs. 3,000 per family is to be advanced to the State Government as Grant.

The entire amount of Rs. 9.00 crores will be released to the State Government keeping in view the movement of these families from relief camps to rehabilitation sites month-wise.

(d) Efforts are being made to shift all the 3000 displaced person families to the rehabilitation sites in Rajasthan Canal Project area by the end of current financial year.]

Death of a power executive engineer

lakh including Rs. 40,000 from insurance and Rs. 20,000 gratuity besides a family pension of Rs. 500 per month;

(b) if so, whether Government propose to advise other State Governments to accord similar grants in similar circumstances to the Government servants; and

(c) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) The U.P. Government have stated that the following benefits have been extended to the bereaved family of the Executive Engineer:—

(i) Ex-gratia	40,884.00
(ii) Group Insurance	40,000.00
(iii) Gratuity	19,116.00
TOTAL	1,00,000.00

The widow of the Executive Engineer has also been provided with a suitable job in the Board. Sanction of family pension is in process.

(b) and (c) As regards such advice being given to other State Governments to extend similar benefits, it may be stated that these matters are entirely within the purview of the State Governments and they are competent to accord such benefits to their employees.
