from the Kerala Government owned companies.

- 5. The Husk Control Order has to be suitably amended for the effective procurement of husk by the State Government and to protect the interest of the workers and the industry.
- 6. Reconstitute the Coir Board immediately giving the representation to the workers.
- 7. Allot sufficient funds to the Kerala Government for the re-organisation scheme submitted by it.
- '8. Nationalise coir export trade.

## Non-suitability of edible oils and other litems in the fair price shops in Delhi

2388. SHRI S. KUMARAN: Will the Minister of CIVIL SUPPLIES be pleased to state:

- (a) whether Government are aware of non-availability of edible oils, suji and certain other items during the first fortnight of December, 1980 in the fair price shops in Delhi; and
- (b) if so, what measures are being taken to solve the problem?

THE DEPUTY MINISTER IN THE MINISTRY OF CIVIL SUPPLIES (SHRI BRAJ MOHAN MOHANTY): (a) and (b) According to the information received from the Delhi Administration, imported edible oil and ter items are generally available in the Pair Price Shops. Wherever there is shortage of any item, efforts are made to augment the supply within the allocations made to the Union Territory of Delhi.
