THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): (a) and b) The pavilion ha_s "^been provided for the "Son of India" exhibition with a view to drawing larger crowds and popularising the Pragati Maidan, thereby increasing TFAI revenues. The expenditure on the exhibition will b_e borne by the organisers. Only routine expenditure on maintenanc_e of the space provided temporarily will be incurred by the Trade Fair Authority of India. No lease money i_s being charged. However. TFAI will recover water and electricity charges from the organisers on the basis of actual consumption.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): (a) Yes, Sir. M/s. Hindustan Thompson Associates Ltd. have been appointed as one of the advertising agents of the Authority.

- (b) Since September, 1980. Publicity jobs are not done from this advertising agency on job-to-job basis after Authority's prior approval in each case.
- (c) This agency was considered by the Authority as better suited for its publicity requirements.
