the import of sugar in 1979-80 and •what are the corresponding figures of exports?

SHRI PRANAB MUKHERJEE; In 3379-80, there was no import of sugar. In the recent period, we have imported sugar only sometime in the mid-80s and that will come in the financial year 1980-81. With regard to profit and loss, particularly this year if we could have exported stigar, we could have earned huge amount of money because the international price went up high.

SHRI DINESH GOSWAMI: My question was whether the Government had to incur a substantial loss for a a number of years to get a foothold in the international sugar market and keeping that in view, whether the Government has decided to retract from this policy because of shortage here.

SHRI PRANAB MUKHERJEE: I will not speak of policy matter but •from mid-60s instead of making losses, we started earning profits. But i am not going to make a research as to at what point of time we incurred a loss and at what point of time we started making profit but from mid-60s we started earning profit instead of loss. In regard to the export policy, we will have to take a decision. Certain international commitment is there; we cannot come out of that but at the same time we will have to see to what extent we can meet our domes-tie requirement and what remains surplus with us. Keeping all these factors into account, we have to take a decision. It will be too premature to make any forecast here.
