Besides, an officer has an edge over a Class III employee in various other areas like medical, conveyance, housing facilities etc.

2 Class I Officers have, however, been demanding the removal of anomalies on a stage.to-stage basis. Keeping their various demands in view, the Management of the LIC has recently offered concrete proposals for the revision of pay scales etc., which contain substantial improvements over the existing pay scalefc and other terms and conditions'of service.

Prices of essential commodities in Gujarat

2406. PROF. RAMLAL PARIKH: Will the Minister of CIVIL SUPPLIES be pleased

- (a) what were the prices of essential commodities, commodity wise and monthwise in Gujarat in 1980;
- (b) what were the measures taken by the Central Government to control the prices of these commodities or rendering assistance to State Government to control the increasing prices: and
- (c) to what extent these measures have succeeded?

THE DEPUTY MINISTER -IN THE MINISTRY OF CIVIL SUPPLIES (SHRI BRAJ MOHAN MOHANTY): (a) A Statement showing retail prices of selected commodities since January, 1980 Ahmedabad is given in Annexure.

(b) and (c) The main thrust of the Government policy is to increase pro. duction of various essential commodities, particularly of commodities in short supply. The public distribution system is being expanded and streamlined. Credit policy, continues to be restrictive. The export of essential commodities is being regulated, while some essential commodities in short supply are being imported. From time to time, Union Government has been stressing on the State Govern. ments to vigorously implement the provisions of the Essential Commodities Act, 1955 and the orders issued under it as well as Prevention of Blackmarketing and Maintenance of Supplies of Essential Commodities Act, 1980.

to Questions

The State Government of Gujarat has strengthened the public distribution system and is implementing strictly variou3 orders issued under the Essential Commodities Act. Shop, keepers have been instructed to exhibit prices of commodities and stock position. A scheme .has been made for distribution of essential commodities such as soaps, matches, soda ash, cloth at reaonable rates through fair price shops.

As a result of these measures during the past few weeks there has been some moderation in the overall price-situation. [See Appendix CXVL. Annexure No. 142]
