#### A.I.B. services in foreign languages

43. SHRI SYED SHAHABUDDIN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) the duration of various A.I.R. services in foreign languages;

(b) the names of countries/regions to which beamed;

(c) the local time in those countries at the time when broadcasts are received;

(d) the estimated daily audience, service-wise;

(e) the average monthly number of letters received from listeners abroad, service-wise, for the last two years;

(f) the number of programme folders supplied free by the A.I.R. to the listeners abroad; and

(g) whether the supply is through the Indian missions or directly to individual listeners?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND

BROADCASTING (MISS KUMUDBEN M. JOSHI): (a) and (b) The total duration of All India Radio services in foreign languages is 30 hours and 40 minutes. The daily duration of the 17 External Services (including English) and the names of countries/regions to which the foreign language services are directed are given in Statement I.

(c) The local time in the target countries is shown in the Statement. [See Appendix CXVI, Annexure, No.

7].

(d) It is not possible to estimate the number of daily audiences for these services.

(e) The average monthly number of letters received from listeners in these countries, service-wise, for the last two years (1978 and 1979) are given in Statement-II.

(f) A total of 12,023 folders in ten foreign languages (Pushtu, Swahih, Tibetan, French, Indonesian, Arabic, Burmese, Persian, Nepali and Chinese) are being supplied to the listeners in those countries.

(g) The supply is made direct to the listeners as well as through Indian Missions abroad. A total number of 9,915 folders was supplied to the listeners directly and 2,108 folders through the Indian Missions.

(b) 97 feature films were granted 'U' certificates and 56 feature films were granted 'A' certificates as shown below:—
