- (b) The required information is being compiled and will be placed on the Table of the Sabha.
- (c) The teacher-pupil ratio in the University Departments and University Colleges during 1978-79 was 1:11.
- (d) The required information is being compiled and will be placed on the Table of the Sabha.
- (e) The number of Centres of Advanced Study recognised by the University Grants Commission is 28.
- (f) 9 Centres of Advanced Study are located in Central Universities, 6 in Delhi University, 2 in Banaras Hindu University and 1 in Aligarh Muslim University.
- (g) The entire expenditure of Central Universities, both in respect of maintenance and development is met by the University Grants Commission. In the case of State Universities, while the maintenance expenditure is met entirely by the State Governments. the development expenditure is shared between the University Grants Commission and the State Governments. A comparison of grants paid by the University Grants Commission Central Universities with those to State Universities will therefore be unrealistic.

## Statement

Promotion of Arabic and Persian Languages

The Government of India is operating a scheme for grant of financial Assistance to Voluntary organisations engaged in propagation and development of classical languages other than Sanskrit, i.e. Arabic and Persian Under this Scheme, grants are given upto 75 per cent of the approved expenditure, to traditional voluntary organisations engaged in teaching and research in Arabic and Persian. A Budget Provision of Rs. 3 lakhs in 1977-78 Rs. 5 lakhs per year during 1978-79. 1979-80 and 1980-81 was earmarked. This also includes provision towards payment of research scholarproducts of traditional ship<sub>s</sub> to Madarsas. Students selected for such scholarships are paid stipend of Rs. 200 per month. 20 scholarships per year are being awarded to scholars under this scheme. The following is the level of expenditure during the last three years under this scheme: -

1977-78	Rs. 3.17 Lakhs
1978-79	Rs. 5.00 Lakhs
1979-80	Rs. 4.00 Lakhs

In view of the encouraging response to this scheme, the budget provision has been increased from Rs. 5 lakhs to Rs. 7 lakhs for the year 1981-82.

An editorial assistance of Rs. 4.00 per entry and cent per cent assistance for printing and publication is given under this scheme.
