The employees engaged on this duty are supplied and masks in order to avoid with aprons inhalation of dust.

All the members of the staff working in the stack area have recently been medically examined in order to assess whether there is any health hazard. Their medical report is awaited and in the absence of medical opinion it is difficult to conclude

whether the dusting duty being per-I formed by the said staff is a health hazard.
