(b) There are 30 units engaged in the manufacture of beer of which 7 have exported beer in small quantities. The exports of beer during the year 1978-79 amounted to 1,65,889 litres valued at Rs. 6.34 lakhs.

(c) Of the firms reporting production to the Directorate General of Technical Development which is estimated to be of the order of 1,40,000 kilolitres of beer, an estimated quantity of 50,900 kilolitres wag produced by concerns belonging to houses registered under the MHTP Act.

Exploration of gold mines

145. SHRI M. BASAVARAJU: SHRI BAPURAOJI MAROTRAOJI DESHMUKH:

(a) whether Government have for mulated any programme to explore hidden mines of precious metals like gold in some parts of the country; and

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) Yes, Sir.

(to) Besides Gold exploration, which is already in progress in Southern part of Kolar Schist Belt, Andhra Pradesh; Hutti Maski Schist Belt in Raichur district and ~~Hosur Yelishirur blocks in Gadag Gold Field in Dharwar district, Karnataka, Singhbhum district, Bihar and Keon-jhar district, Orissa, the Geological Survey of India has also taken up high priority Gold exploration programme in the Northern part of Kolar Schist Belt in Karnataka.

Major resources of Gold so far estimated include Gold bearing rock of 0.3 million tonnes with 5.5 gram-

mes per tonne in Mallappakonda area, Chittoor district and over 3.1 milliom tonnes of gold bearing rock in Kolar Gold Field, Karnataka. In Gadag Gold Field over 0.56 million tonnes of gold bearing rock in Mopla Lode, in Hutti Gold Field 0.06 million tonnes and in Anantapur Gold Field (A.P.), 1.64 million tonnes, of resources of gold have been estimated by Geological Survey of India and other agencies. Gold content generally ranges between 5 to 8 grammes per tonne.

Impact of Iraq-Iran war on tourist traffic to India
