North-Eastern, the agency that should be entrusted to operate such services, the routes and other associated details, are yet to be worked out and decision taken.

Tourist Potentialities of Mahabalipurm in Tamil Nadu

*29. SHRI R. MOHANARANGAM: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) the particulars of the Master Plan for the development of tourist potentialities of Mahabalipuram in Tamil Nadu;
- (b) what is the estimated cost of development of this tourist spot; and
- (c) what are the particulars of the phased programme and by when the work is likely to commence?

THE MINISTER OF TOURISM AND A. P. CIVIL AVIATION (SHRI SHARMA): (a) to (c) No such master plan has been prepared by the Government of India. However, such a plan on Mahabalipuram has been prepared by the State Government, which includes civic improvements within the old township, improvements in and near the area where the mounments are located, the proposed tourist town centre, construction of public utilities and expansion of recreation accommodation facilities. The total cost for implementation of the Project Report is estimated at Rs. 5.82 crores.

The Co-ordination Committee set up by the State Government to review the various estimates contained in the Project Report has recommended implementation of five out of twentyfive proposals in the first phase, namely, construction of the ring-road.

the transport terminal and the shopping plaza, vista formation (landscaping) and provision of recreational facilities at a total estimated cost of Rs. 173 lakhs.

In view of the heavy cost involved in the implementation of the Project Report: the State Government was requested in September 1980 to review the cost estimates contained in the Project Report and to assign responsibilities for the implementation of the schemes to various agencies at the Central and State level. The reply from the State Government is awaited.

Inflation and Price Rise

*30. SHRI NARASINGHA PRASAD NANDA.

SHRI KALPNATH RAI

Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that he has stated recently that the inflation in the country is under control;
- (b) if so, whether the rate of inflation has come down from 2-3 per cent to 1 per cent;
- (c) whether the prices are also likely to come down with the rate of inflation going down; and
- (d) if not, what action Government propose to take to check the rise in prices?

THE DEPUTY MINISTER IN THE FINANCE MINISTRY OF (SHRI MAGANBHAI BAROT): (a) Sir. There is some moderation in inflationary pressures as indicated by the wholesale price index.

(b) to (d) The monthly rate of inflation as measured by the Wholesale Price Index (1970-71-100) which rose from 2.5 per cent in May, 1980 to 3.0 per cent in June, 4.1 per cent in July, came down to 1 per cent in August, 1.7 per cent in September and 0.6 per cent in October. For the successive weeks ended 25-10-1980 and 1-11-1980 the All Commodities Wholesale Price Index fell by 1.2 per cent and 1.7 per cent respectively

Taking the recent three months, August to October, the average rate per month works out to 1.1 per cent, as compared with the averag of 3.2 per cent for the previous three months (May-July). However, Government keeps a careful watch on the price situation and will take further suitable anti-inflationary measures as and when considered necessary.
