- (i) If a guide is required to report before 0700 hours or finish his|her assignment after 2130 hours, he|she will be either provided transport by the agency to pick him/her up/ drop him/her at his/her residence or given Rs. 5.00 as transport allowance. Except in Varanasi in cases where on Sunday and closed holidays the public transport services do not operate at the time when the guide is asked to report for duty or after he is free from his assignment even if it is later then 0700 hours or earlier than 2130 hours, he/she entitled to transport allowance. It a guide has a full day assignment leaving before 0700 hours and returning after 2130 hours he/she will be entitled to receive Rs. 10.00 as transport allowance.
- (ii) AH other charges i.e. First Class train fare, Bus fare, taxi hire charges for sightseeing etc. will be paid by the party/travel agency hiring the guide.
- (iii) If a guide is required to accompany a party travelling through India by air, the air fare-ticket should be provided to him/her for the journeys by air.
- (iv) If the guide is required to join a party at a station which is not his I her headquarters, he | she cannot insist on free air fare unless the party is willing to pay for this journey, However he/she will be entitled to First Clasg train fare plus Rs. 25.00 as incidental charges to cover transport charges from residence to railway station, meals on the train porterage, etc.
