THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI MAGANBHAI BAROT): (a), (d) and (e) The National Defence Gold Bonds, 1980 fell due for redemption on 27th October, 1980. Holders of these bonds have already been advised of the arrangements made for the return of gold to tnem. A copy of the Press Communique issued on 22nd September 1980 giving the necessary information is enclosed.
