THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) to (c) Yugoslav President did not visit India in September, 1980. However, President of Yugoslav Federal Executive Council, H. E. Veselin Djuranvic came to India and during the course of his visit a long-term agreement on economic, industrial, trade, scientific and technical cooperation between India and Yugoslavia was concluded. The Agreement envisages further expansion and strengthening of bilatteral cooperation between, the two countries in diverse fields, including trade. As a result of the agreement, trade between the two countries is likely to increase but it is difficult to quantify the likely increase at this stage.
