(a) According to assessment made by the Indian Institute of Petroleum, the broad sectoral consumption of High Speed Diesel Oil amongst various consuming Sectors is as below:—

- (b) At present, India has 14,544 Kms. of navigable inland waterways and on the basis of available data as on 31-3-78, the registered number of mechanised Crafts engaged in inland waterways was 1231.
- (c) Indian coastal shipping as on 30-11-80 consists of 59 ships, with 0.26 million GRT. The main commodities that have been carried or can be carried in the coastal trade are salt, coal, foodgrains, cement, iron ore, other ore and POL. However, the coastal trade at present is mainly in coal, salt and POL.
- (d) As on 30-11-80, there have been 384 ships of 5.68 million GRT. The national ships carried Indian overseas traffic of 27.60 million tonnes, 22.82 million tonnes and 23.31 million tonnes during the year 1976-77, 1977-78 and 1978-79 respectively, besides they have also loaded 4.3 million tonnes, 5.1 million tonnes and 5.3 million tonnes coastal cargo during these years.
